

Meeting minutes from CP SWG on 19 April 2023, at 10.00 am to 12.00 pm (online)

1. Discussions on CP SWG log frame

- The ISWG has requested each sector to update their log frame for 2023. The log frame needs to align the output statements with the indicators for each output, and the indicators need to be SMART
- The CP SWG members have been asked to submit the indicators for 2023 to inform the revision of the CP SWG log frame for 2023, which many organizations did.
- There have been two preparatory meetings on the review of the log frame, which various members attended to support the process. During these meetings the indicators from last year were reviewed and compared to the member's indicators for 2023. Based on this, suggested output statements and indicators were developed for the log frame 2023.
- In the current CP SWG meeting, the drafted log frame was reviewed for members to provide feedback and comments. These comments included the following areas: addition of more qualitative indicators, which services (especially cash assistance) to include in the case management indicators, whether and where to include unstructured and structured activities, reformulate the policy/advocacy indicator, including indicator to measure number of paralegals/community-based volunteers for sustainability of programmes as well as which indicator to include for parenting programme.
- The log frame will be amended based on the comments and reviewed on the joint full planning day 4 May 2023 (TBC) for its endorsement. Then it will be shared by the ISWG.

2. Presentation on international instruments related to child rights by UNRC

- The colleagues, Christina and Rascha, from UN Resident Coordinator's Office (UNRCO) held a presentation (see attached herein) on the child rights related international instruments that Jordan have signed/ratified – which is 8 out of 10. Particular focus during the presentation was on the UNCRC and the UPR.
- For the UNCRC, Jordan has submitted its State Party Report, which will be reviewed in the CRC Committee in Geneva on 9-10 May. The deadline for a shadow report by civil society was mid-April 2023, hence it is no longer possible to submit such report. There is a possibility to join the session on 9-10 May online, which the members were encouraged to do. UNRCO is recommending a meeting after the conference to discuss our support to the Government to implement the recommendations that will be given based on the status of the UNCRC implementation in Jordan.
- For the UPR, there is still a chance to submit a shadow report by the civil society actors **until mid of June 2023**. The UPR discussions for Jordan will take place in January 2024.
