Presentation on Mapping of GBV	<p>AMI presented their plans to map GBV services within health services and informed participants they may be requested to fill in a questionnaire in the coming weeks. The mapping has been commissioned by WHO to enable them to best understand how they can add value for training and strengthening the health service. The mapping will be done at primary, secondary and tertiary level and will involve a desk-based review of the literature and questionnaire of GBV actors both governmental and non-governmental organisations. Carmen from ANES offered to share their existing mapping of social services and to help with the research. It was reiterated this is not a comprehensive research of GBV services but it could help to inform future trainings in collaboration with ANES.</p> <p>Shiori (UNHCR) talked about the GBV training calendar on the IA sharepoint, and participants were encouraged to add any trainings in GBV response to the calendar to prevent overlap.</p>
WHO Resources on GBV care	Nicky and Annet talked about some of the resources available from WHO for GBV care to be used in healthcare settings. Some of these are already being translated into Romanian (in Moldova) and NM will make them available to the group as soon as they are finished. The presentation is available.
Updates/AOB	<p>Daniela (EEIRH) highlighted that many CSOs/NGOs were now lacking funding for the emergency Ukraine response and the GBV hotline in Iasi has now closed due to lack of funding.</p> <p>Rossy announced UNFPA have appointed a GBViE expert who will work with EEIRH in Romania. There will also be a SRHiE expert starting soon in Poland who will also cover Slovakia and Romania. They will be introduced to the group when they are in post.</p> <p>She also announced a ToT in CMR following the 5-day CMR training which is planned for October.</p>
