humanitarian aid program for the Ukrainians. BHC also continues with their hotlines. BHC is actively advocating for the new government decision to extend the temporary protection deadline for Ukrainians. BRC/Dr. Sofia informed about BRC protection activities for 2023 (all information is also available on the BRC webpage): BRC will operate three helplines (for MHPSS in Plovdiv, a child helpline with the government); provide cash assistance; provide psychosocial support, restoring family links services and child protection services; capacity building on inclusion, language and legal support. BRC branches throughout the country also provide consultation and referrals. Cash assistance was also provided to 7,833 children (3,828 boys and the 4,005 girls). BRC will continue with trafficking prevention activities and services in the Blue Dots. Aid for Ukraine/Ksenia updated that in 2022 they opened an integration centre in Sofia. In 2023 they will continue implementing projects in cooperation with UNICEF and WHO. Aid for Ukraine has access to several UKR Facebook groups that bring together more than 50,000 Ukrainians and seeks feedback from Ukrainians through the digital platform. In the Center, there are languages courses for children as well as psychosocial support and art therapy. (Aid for Ukraine also assists UKR women with employment support/opportunities and with the provision of medicines under the Livelihoods and Basic Need sectors.) FAR provides legal aid to asylum seekers, stateless persons, migrants and refugees, including children, through its lawyers in the regions of Bourgas, Dobrich, Plovdiv, Varna and Sofia, including legal aid at the Blue dots in Dobrich, Bourgas and Varna. FAR complements traditional legal aid with digital legal aid channels via the online platform Migrantlife.bg. UNHCR/Maria updated that in 2023 UNHCR will continue activities with regards to UKR access to Bulgarian territory, focusing on monitoring reception conditions, accommodation, access to rights, and identification of persons with specific needs, as well as the referral to services and ensuring the effective access to all these services. UNHCR will also continue with cash for protection program. UNHCR will also focus on integration activities, looking for more longterm solutions. UNHCR will continue with UNICEF jointly to further expand the Blue Dots. UNHCR will also work on youth engagement and empowerment. UNICEF/Carole: informed that UNICEF in 2023 will further expand their partnerships with line ministries as well as with the State Agency for Refugees, State Agency for Child Protection, local authorities - providing technical and financial support, advice, policy, advocacy, training, supervision, exchange of good practices and coordination. Child protection includes legal assistance knowledge and access to social services, also the distribution of core relief items, especially during the winter. UNICEF will be engaged with MHPSS activities, youth engagement and cash for

| | protection assistance – as well as continued service provision through the Blue Dots. UNICEF will ensure a multi- sectoral approach and focus on cooperation with Ukrainian and Bulgarian civil society actors. |

| | USRF/Olena shared that USRF will continue to work on receiving and assisting vulnerable Ukrainians in their centre. There are also other projects as psychosocial support, day-care centre for children, in cooperation with UNHCR and UNICEF. |
| | <u>IOM/Mariya</u> briefed the participants about the activities in 2023 which include access to medical service, cash, MHPSS related activities, translation of documents ad hoc support. IOM has closed the Asylum Migration and Integration Fund projects with the Ministry of Interior. Two safety zones – in Ovcha Kupel and Voenna Rampa – will remain till the end of 2023. IOM sub-office in Harmanly will also remain open. |
| | <u>Participants discussed the IACWG forum and government's Task Force meetings</u> : On the question of BHC/Iliana what would be the difference between the IACWG (with the government's participation/eventual co-lead) and government operational task force meetings, , the <u>Inter-Agency Coordination Officer</u> reiterated on the importance of the government-led response and humanitarian actors' support to this, hence the objective to bring together all relevant actors as to have one dialogue and work jointly on the crisis response. Then BHC/Iliana suggested that the IACWG forum should also strongly advocate with the government Operational Task Force to organise meetings with UN agencies and NGOs on a more regular basis. |
| | <u>UNHCR/Petya</u> added that the decision on the extension of Temporary Protection is expected to be adopted during the meeting of the Council of Ministers, and the government will start extending the Temporary Protection registration cards. Some employers do not want to employ Ukrainians whose temporary protection is expected to expire by 24 February. The Government might adopt a decision for a three-month extension. |
| Protection Working Group | Re the proposal of bringing the Protection Working Group under the Inter-Agency Refugee Coordination Forum: UNHCR/Mariya briefed on the existing Protection Working Group: It has been set up as a national coordination mechanism in the context of the Syrian refugee situation, to bring together NGOs working on the response and discuss specific issues. It was chaired jointly by UNHCR and BHC. SAR has been present at these meetings. Various issues of relevance to asylum seekers and refugees were discussed and the findings were presented to the regular coordination meeting chaired by SAR, monthly. |
