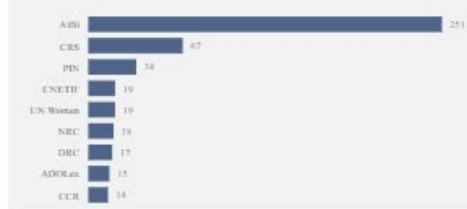

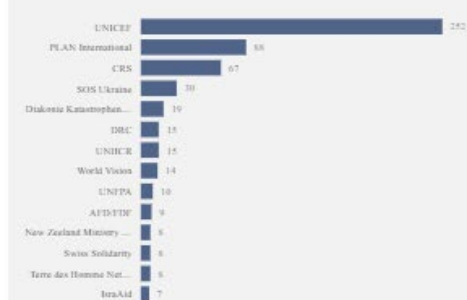

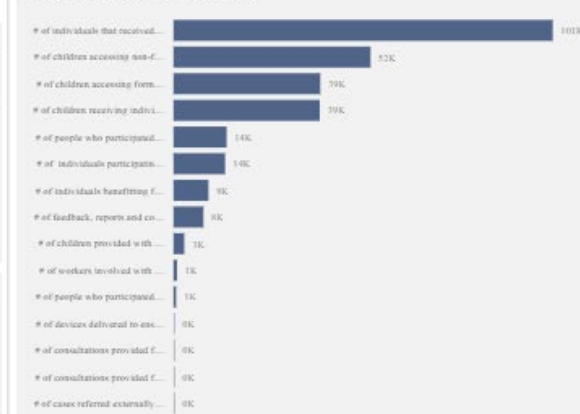


of activities by donor/mandating agency

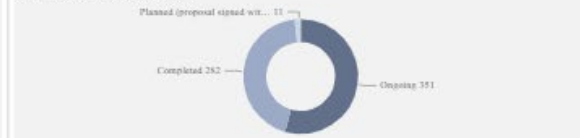

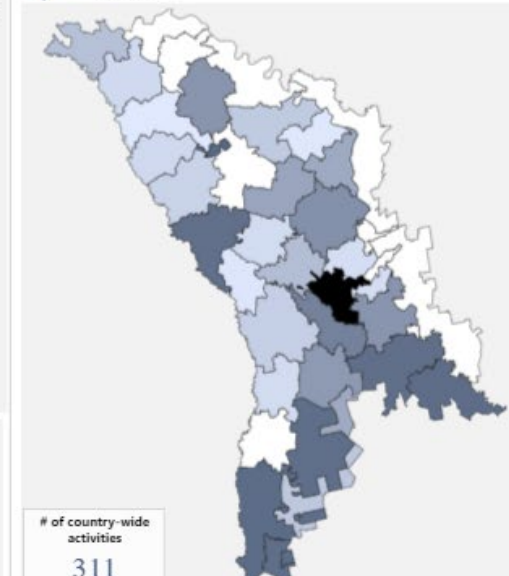
