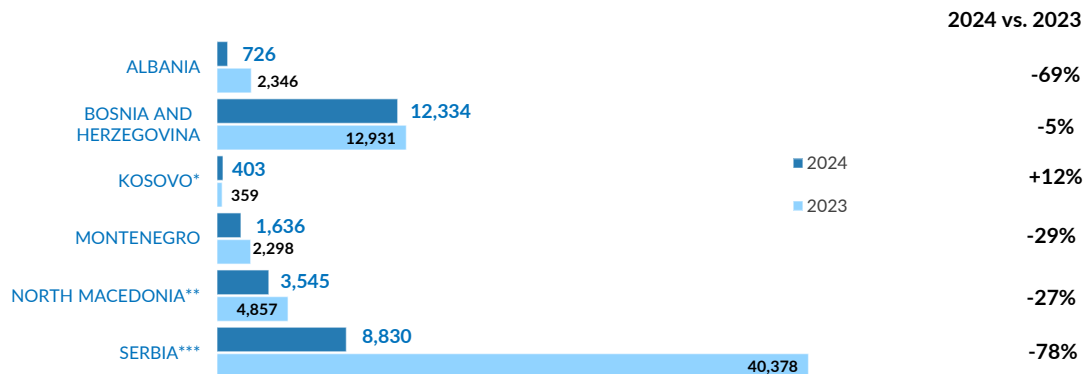

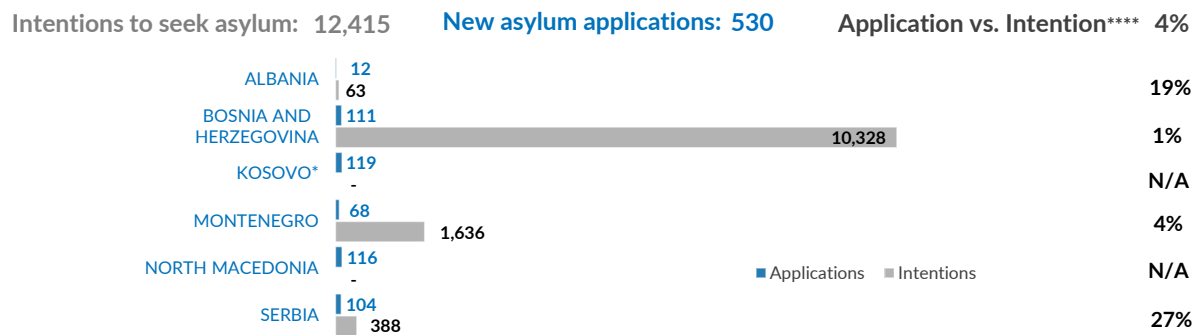
New arrivals¹: January-June 2024 vs. January-June 2023



Estimation of Persons of concern in Mixed Movements in the region as of 30 June:

Between January and June, some **5,100** refugees and migrants were estimated to have transited through the Western Balkans as part of mixed movements, **50 per cent less** than in the same period last year. Given the nature of movement of these persons, including as a result of pushbacks and/or reverse flow, UNHCR uses data on arrivals to estimate how many persons are a part of mixed movements in a given time period.

Asylum statistics in the Western Balkans in 2024:

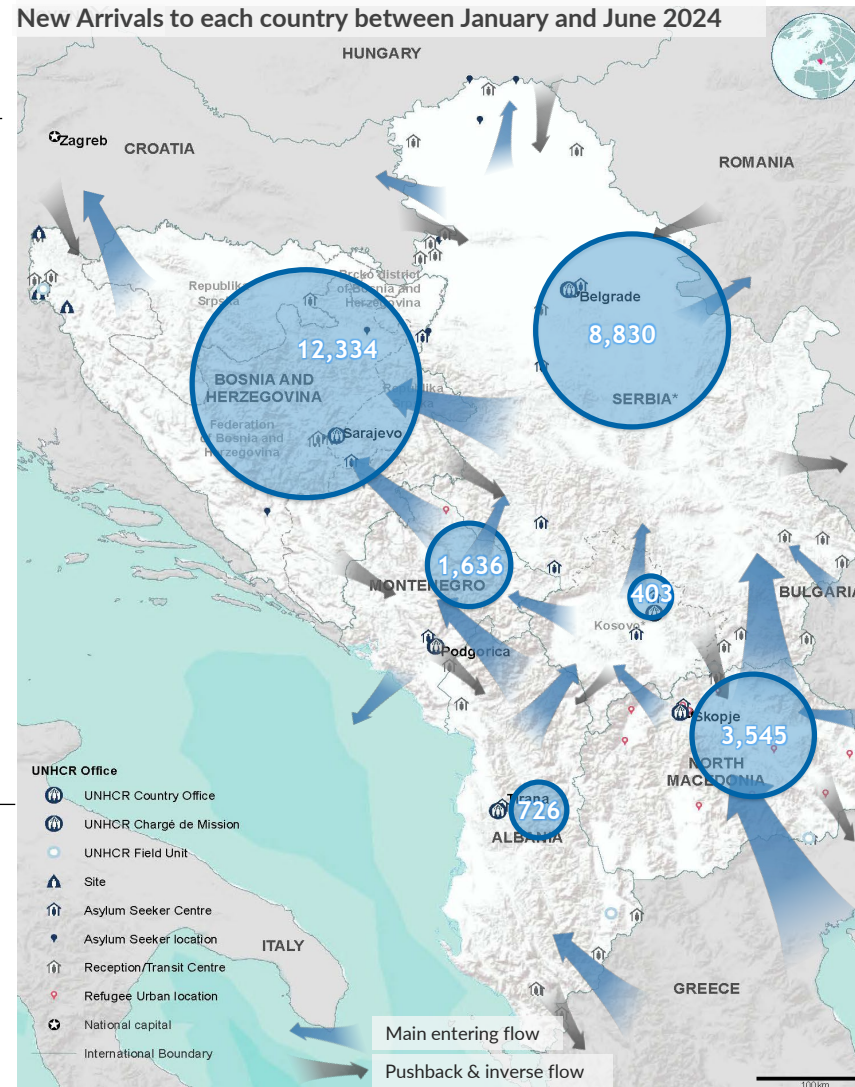

New Arrivals to each country between January and June 2024



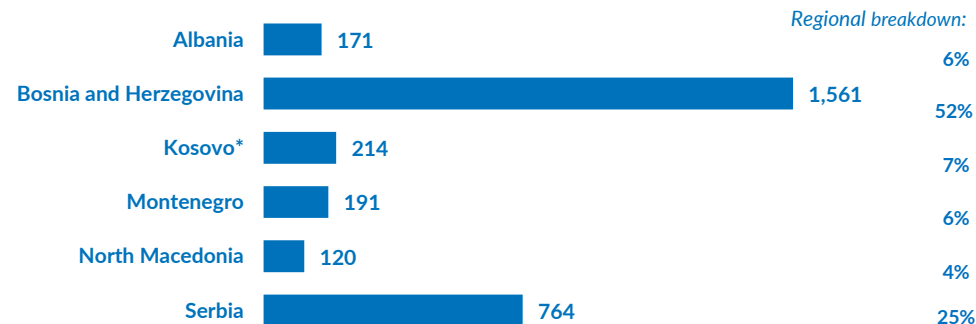

Note: Data presented in this dashboard is collected by UNHCR in the Western Balkans, including data collected by UNHCR Public Information focal points, data collected through Border Protection Monitoring (BPM), as well as monthly arrivals and asylum statistics provided by authorities in each country. This data should not be considered final and may change as per the latest updates made available by the authorities. Persons in Mixed Movements are considered 'new arrivals' as a part of irregular flow. Data on irregular arrivals and transit of persons through the countries in the Western Balkans may contain double counting of the same persons. It is, therefore, advised not to use the sum of these figures.

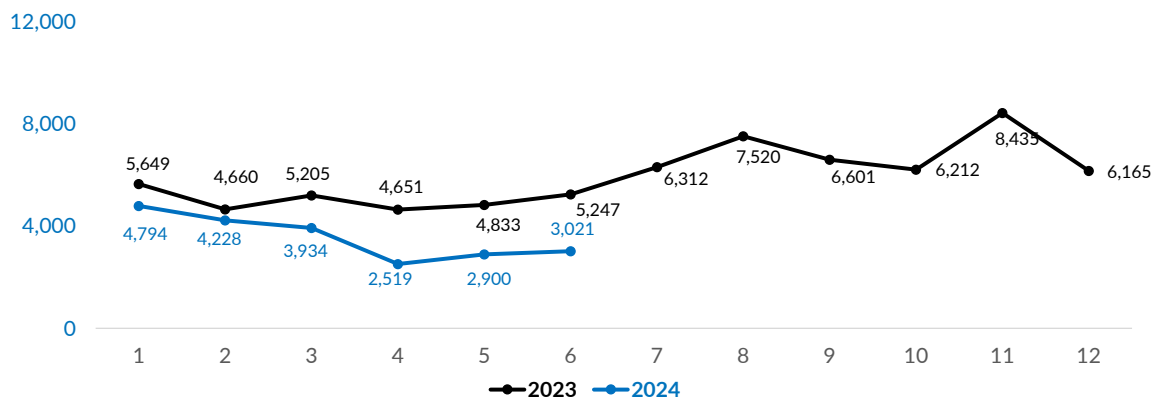
Forcibly Displaced and Stateless People present at the end of June:

Some **3,000** persons were present in the Western Balkans as of end June 2024, including **199** unaccompanied and separated children (UASC). Of these, 52% were present in Bosnia and Herzegovina, followed by Serbia (25%), Kosovo (seven per cent), Albania & Montenegro (six per cent each) and North Macedonia (four per cent). This also includes estimated number of persons present outside government-run centres.

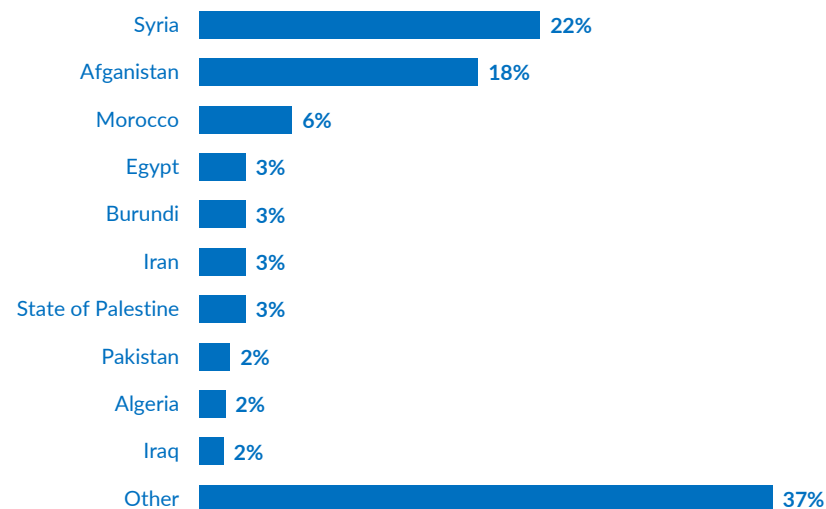
Forcibly Displaced and Stateless People present in the Western Balkans countries are accommodated in government-run centres; IOM-run centres, asylum-seekers and persons granted international protection in asylum centres and persons on the move in transit centres.



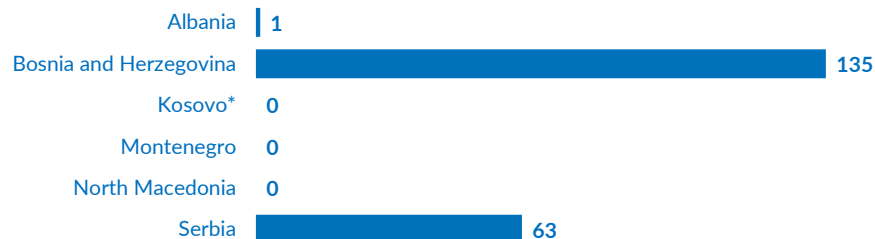
Forcibly Displaced and Stateless People present at the end of reporting period by month:
