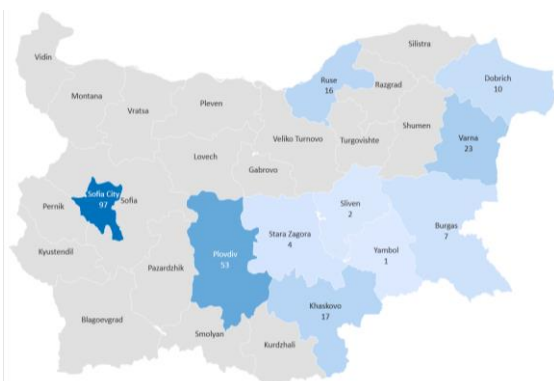

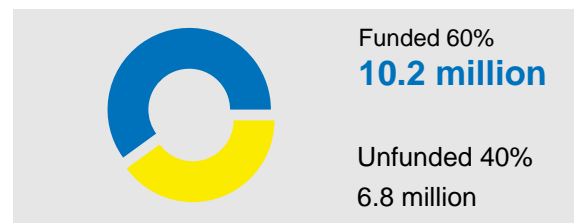

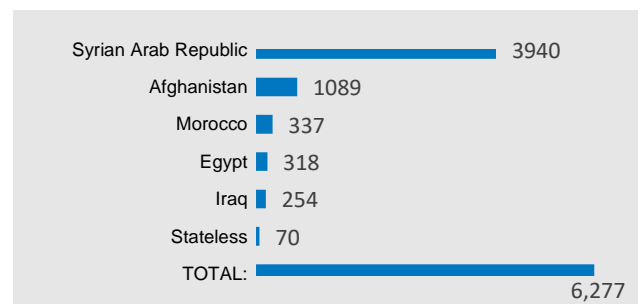
TP REGISTRATIONS IN BULGARIA BY REGION

Update on Achievements

Operational Context

The evolving situation in Ukraine and the changing needs of refugees have led to a realignment of UNHCR's areas of intervention. UNHCR's efforts are accelerating in fostering inclusion through access to livelihoods opportunities and to national social protection system and promoting community resilience and mobilization.

Prevailing protection gaps with respect to international protection applicants and beneficiaries necessitates reinforcement of UNHCR's work in several key areas. These include facilitating access to territory and status, improving reception conditions, enhancing access to the national social protection system, and bolstering community mobilization and support. Our aim is to create a more supportive environment for protection and inclusion from the moment individuals arrive and throughout their integration process after their status is recognized. Refugees, in particular unaccompanied children and other vulnerable persons should have access to protection and solutions regardless of considerations about their assumed intentions.

UNHCR is committed to identifying and addressing statelessness and the risk of statelessness among displaced populations. We are collaborating closely with national authorities and the civil society to map out stateless populations and those at risk, while also supporting the Government's capacity to find sustainable solutions and mitigate the risk of statelessness.

Key Highlights

Due to the lack of majority for a formation of a regular government, Prime-Minister-designate Ms. Goritsa Grancharova was asked to establish a caretaker government. President Rumen Radev rejected the government on 19 August due his dissatisfaction with the nomination for a Minister of Interior, a position which is key for the organisation of the upcoming elections. The mandate for the creation of a new Caretaker Government was later given to current Caretaker PM Dimitar Glavchev. His largely unchanged government, with a replacement of the Minister of Interior, was approved. The new caretaker cabinet assumed function on August 27 and snap elections are scheduled for 27 October 2024.

UNHCR Bulgaria, in collaboration with the Ministry of Education and Science and UNICEF, has launched an information campaign on school enrolment, starting in Burgas region, with plans to extend it to Varna. The campaign involved sessions in refugee communities and included representatives from Regional Education Administrations.

On 31 July, the Council of Ministers adopted a decree to regulate the access of refugees with Temporary Protection to Bulgarian state universities, increasing the enrolment quota from 150 to 400 students following UNHCR advocacy. The Ministry of Education and Science is drafting a decision to specify the number of places available per specialty, which will be open for public consultation. Refugee students are expected to start the application process by mid-September for the academic year beginning on 1 October.

UNHCR Bulgaria conducted a training session for 16 newly deployed FRONTEX officers stationed at the Bulgarian-Turkish border as part of their induction program. The training covered principles of international, EU, and national law, focusing on managing mixed migration flows while ensuring respect for fundamental rights and non-refoulement.

On 8 August, Kimiya Alizadeh won a bronze medal in taekwondo at the Paris Olympic Games in the 57 kg category. A former Refugee Olympic Team member, Alizadeh was granted Bulgarian citizenship earlier this year and won the European title in her category shortly after. She is Bulgaria's first-ever taekwondo representative at the Olympics. Alizadeh's journey has garnered significant media attention, and on 16 August, she visited the UNHCR office in Bulgaria, and discussed potential future collaboration initiatives to provide continuous support to the refugee community through consistent engagement aimed at enhancing opportunities for refugees in Bulgaria through sports.

Key Priorities in 2024

- **Access to territory and legal status:** UNHCR and partners regularly monitor borders, reception centres, and detention centres to ensure asylum-seekers can [access fair and efficient procedures](#) through [information](#), [legal counselling](#), and [assistance](#).
- **Asylum procedures:** UNHCR supports Bulgaria in enhancing the quality of the asylum system through [capacity-building activities](#) for authorities to ensure fair and efficient procedures, monitors international protection procedures and provides guidance and recommendations.
- **Child protection:** UNHCR works with institutions to strengthen the national child protection system in early [identification](#), [access to adequate reception conditions](#), and ensuring representation and guardianship, and expansion of [alternative care arrangements](#) for asylum-seeking and refugee children at risk. UNHCR also provides education and child protection services through partners.
- **Education:** UNHCR will continue to support children in their academic, language, and inclusive education and psychosocial support to integrate into the Bulgarian school system. UNHCR and the Ministry of Education and Science will promote enrolment in the Bulgarian school system by removing institutional, sociocultural, and economic barriers and support development of preparatory classes and availability of language courses. UNHCR will also work with authorities and academic institutions to promote access to tertiary education and diploma recognition.
- **Community Based Protection:** UNHCR launched together with partners a joint initiative for the opening of a network of 6 Protection and Inclusion Centers called [Compass](#).
- **GBV:** UNHCR works with State, humanitarian partners, and community members to prevent and mitigate risks, and provide a comprehensive and safe response to gender-based violence (GBV). This includes [raising awareness](#), [strengthening referral pathways](#), and [implementing safety audits](#).
- **Inclusion:** UNHCR fosters refugee [socio-economic inclusion](#), collaborating with local stakeholders on job-matching, employability, and small business initiatives. Additionally, a [Refugee Employment Platform](#) has been launched, as part of a regional UNHCR initiative, to facilitate refugee employment.
- **Mental Health and Psychosocial Support (MHPSS):** UNHCR and partners provide family and community support activities, including through awareness raising and psychoeducation, arts based psychosocial support groups and support groups for parents, amongst others. Likewise, partners provide individual counselling to asylum-seekers and refugees, including referrals to specialized services, while working to improve access to quality MHPSS services.
- **Working with partners:** UNHCR supports the government to ensure policies and legislation are in line with international standards, and promotes a comprehensive refugee response, grounded in [multi-stakeholder](#), [“whole-of-society”](#) approaches that includes refugees, local authorities, international organizations, civil society, private sector, and other stakeholders. UNHCR in 2024 works with [seven partner NGOs](#) to safeguard the rights and well-being of people forced to flee, deliver assistance, and promote refugees’ social protection and access to livelihoods, education and inclusion.
- **Statelessness:** Bulgaria acceded to both the 1954 and 1961 UN Conventions on Statelessness, and introduced a statelessness determination procedure in 2017, granting stateless status to 161 people so far. Following pledges at the High-Level Segment of Statelessness in 2019, the Government has improved the quality of statelessness determination procedure and included stateless people in the 2021 Census. During the 2023 GRF, Bulgaria pledged to regularly review the remaining reservations to the 1954 Convention Relating to the Status of Stateless Persons.
- **External Relations:** UNHCR works with whole-of-society partners to showcase the hopes, dreams, diverse talents, and the positive impact of refugees on their host communities, and to promote solidarity, support, and inclusion for refugees.
- **PSEA Network:** An inter-agency Protection from Sexual Exploitation and Abuse (PSEA) network was established by UNHCR and UNICEF in 2023, involving funded partners and authorities to prevent and mitigate SEA risks. A national NGO is also part of the network chairing arrangements. This initiative aimed to ensure a robust complaints mechanism, establish PSEA focal points, conduct joint risk assessments, build partner capacity, and engage in community outreach on trafficking and SEA risks.
