



RRP 2025-2026 Objectives

- 2 years plan
- Objectives should be neither short-term or immediate, enabling partners to consolidate their efforts, achieve results over time and ensure a sustainable whole-of-government and whole-of-society approach.
- Focus on:
 - promoting effective inclusion in the national health insurance scheme for refugees
 - ensuring the sustainability of the response
 - refugee empowerment and self-reliance
 - continue supporting and strengthening national health system
 - provide targeted support to vulnerable members of the host community
 - engaging more with national/local civil society organizations, municipalities, and refugee-led organizations
- > Align with:
 - NEXUS principles and the Inclusion Mechanism of foreigners to the National Development Plan

2025-2026 RRP health objectives

- 1. Address and reduce financial and administrative barriers for refugees in accessing quality health services.
- 2. Facilitate access to quality, timely essential health services (preventative and curative), essential medical products, vaccines and medical technologies and support and strengthen the health workforce to provide services to refugees and vulnerable host populations.
- 3. Prevent and respond to existing and emerging public health threats among refugees and vulnerable host population.
- 4. Health sector leadership and governance mechanisms are streamlined, and emergency health information is reinforced for the evidence-based response, grounded around the humanitarian-development nexus principle.
