Overview →

The Uganda Country Refugee Response Plan (UCRRP) involves partners in a coordinated effort to protect refugee children from abuse, neglect, exploitation, violence, and separation, including GBV, child labor, while ensuring access to quality child protection services. To support the UCRRP, the Uganda Inter-Agency Child Protection Strategy (2023-2025) focuses on three key objectives: strengthening the national child protection system; providing essential services such as case management and alternative care; and supporting children, families, and communities in safeguarding children. Child Protection (CP) programming is severely affected by funding cuts, impacting over **89,202** children with Child Protection-related specific needs and **55,153** needing case management. Staff reductions have compromised service quality, with the average caseworker-to-caseload ratio at **1:155**. These figures far exceed the global standard of **1:25**, highlighting critical capacity gaps.

Results Analysis and Achievements in 2025:

During the reporting period, **23,893 (11,578 girls and 12,315 boys)** children received child protection case management services such as alternative care arrangements, family tracing and reunification, psychosocial support, referrals among others. Additionally, a total of **12,913 (5,538 Unaccompanied and Separated Children (UASC) and 7,375 Child at Risk (CR))** child protection cases were successfully closed after resolving the protection concerns. The active CP cases stood at **10,980**, **9,281** cases were newly identified in 2025 majorly from Sudan and DRC. Furthermore, family tracing was initiated for **421 UASC**, with **226 (54% successfully reunified with family members)**. Lastly, **27,446 (8,636 Men and 18,810 Female)** parents (**representing 128% of the annual target**) participated in positive parenting sessions under the family strengthening program.

By the end of Q4, **150,584 (73,974 girls and 76,610 boys)** children (**representing 56% of the annual target**) aged 5–17 participated in community-based support activities such as play and recreation activities, reflecting funding-driven reprioritization. Meanwhile, **45,815 (25,344 girls and 20,471 boys)** adolescents (**representing 75% of the annual target**) engaged in targeted programs aimed at skill development. Currently, **18** Child Friendly Spaces (CFS) centers remain operational, offering basic services; this represents a **48%** reduction compared to the same period last year-2024.

The Key Challenges/ Opportunities in 2025:


- Limited resources both financial and human, which constrained the ability of child protection actors to provide adequate case management, psychosocial support, family tracing, and follow-up for children at risk. This challenge is compounded by high caseloads, particularly in refugee-hosting districts, where social service workforces are overstretched and lack sufficient training, transportation, and tools to respond effectively.
- Poverty and household vulnerability also remain key drivers of child protection risks. Economic pressures increase the likelihood of child labour, early marriage, and school dropout. Additionally, limited access to education and child-friendly services exposes children to heightened protection risks. Cultural norms, stigma around reporting abuse, and community silence further hinder early identification and response to cases of violence or exploitation.
- Operational challenges include inadequate coordination among government, humanitarian, and development actors, as well as gaps in referral pathways, legal and policy enforcement remains uneven and emerging risks such as climate related displacement, digital safety concerns, and insecurity also exacerbate children's exposure to harm.
- Despite these challenges, the prospects for improvement remain strong. Continued investment in strengthening national child protection systems, including social service workforce development and case management digitalization, offers a pathway for sustained progress. The government's commitment to child protection reforms, alongside the expansion of community-based protection mechanisms, presents opportunities to improve early reporting and prevention. Stronger multisector collaboration linking education, health, justice, and protection can create a more integrated safety net for children. Expanding livelihood and resilience programmes for vulnerable households will also reduce economic drivers of child abuse.

The Sector Priorities for 2026:


- Aligned with the Inter-Agency child protection strategy and CP Sub-Working Group (CPSWG) workplan for 2026, the sector will continue to prioritize the strengthening of an inclusive child protection system, localization of case management services through triaging, leveraging on existing community structures including parasocial workers to enhance early case identification and referral.
- Continue with alternative care arrangements for Unaccompanied and separated children, and support for children, families, as well as communities in preventing and responding to child protection risks. Additionally, build on integrating MHPSS services in child protection and GBV.




No of Children at Heightened Risks who Received Quality Case Management Services, **Target: 37,500**




Best Interests Procedure(BIP)








Open Child Protection Cases Age, Gender Breakdown




Best Interests Assessments (BIAs) Age, Gender Breakdown






Children Participating in Community-Based Support Activities Age, Gender Breakdown




Adolescents Participating in Targeted Programs By Gender Breakdown


