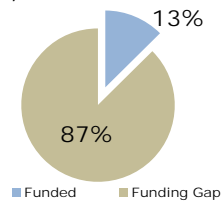


2015 SOUTH SUDAN REGIONAL REFUGEE RESPONSE PLAN
