





# Current Situation\*

## Timeline

- ✓ **6 March - 10 April** : Work at sector level
- ✓ **10 April** : Sectors leads/ co-leads submit consolidated Sector drafts
- ✓ **11- 15 April** : RRP focal points consolidate Lebanon Country Chapter
- ✓ **18 - 19 April**: Draft RRP country chapter circulated to all agencies for comments after approval
- ✓ **19-25 April**: Review of country chapters at regional level
- ✓ **28 May**: Launch of RRP5 in Geneva



# REVISED SYRIAN REFUGEES RESPONSE PLAN 5

## Key points on formats

- **Sectors: follow coordination structure**
  - Financial requirements table will be amended
  - Additional section on social cohesion and livelihoods
  
- **Presentation of needs: appeal responds to all needs**
  - Sectors must identify priorities. Unmet needs refer to what the humanitarian community cannot address
  
- **Financial requirements and targets are cumulative**
  - They cover the period January – December 2013
  - All agencies to provide total requirements as well as sectoral requirements
  
- **Support**
  - UNHCR 'buddies' and guidance available as of Monday

# SHELTER-Update

## Highlights:

- GoL authorized the establishment of one transit site in Bebnine, N-Lebanon;
- Farm pilot project started in N-Lebanon;
- Mapping of Informal tented settlement in the Bekaa finalized, North being done
- 11,885 HH, 60129 IND received shelter assistance since 2012

## Action Points:

- Sector strategy has been updated and is being finalized;
- Regional operation/contingency plans being prepared



# WASH - Update

## Highlights:

- RRP5 submissions from partners were received and reviewed.
- Draft capacity assessment report (WASH partners) was shared with lead and co-lead and comments are sent to the assessment team.

## Action Points:

- Meeting with Water Establishments to discuss planning and coordination related issues.
- Revision of new comer hygiene kit.
- Finalize technical documents on water, sanitation and hygiene promotion.




# PUBLIC HEALTH-Update

## Highlights:

- New public health strategy being discussed with partners
- Assessment of all PHCs directly linked to UNHCR
- Negotiations with SHC providers (hospital directors) for flat rates, discounts and max contributions of refugees
- Second phase of measles & polio campaign (MOPH/UNICEF/WHO)

## Action Points:

- Dissemination of PH strategy to all partners and colleagues in field
- Discussions with PHCs for better service packages at reduced fees
- Finalization of RRP5



# EDUCATION - Update

## Highlights:

- The school strike ended and schools reopened
- Reports on drop-out due to bullying in school increasing
- The EWG is preparing for the RRP5 and through this further harmonize the education interventions

## Action Points:

- The Joint Education Needs Assessment to resume
- The MEHE and EWG partners need to act upon the reports on bullying and together with the Child Protection Working Group look into a strategy to counter this



# NFI-Update

## Highlights:

- Rapid Estimate of Unregistered Numbers & Locations:
  - 21,521 Newcomers during March in 1,404 places (out of 2,800 'P-codes')
  - cannot yet tell how many 'N's there are
- NFI Kits standardized:
  - Arrival Kit (= a blanket pp, 4 mattresses, 1 kitchen set, 1 hygiene set, 1 baby set)
  - Registration Kit (= voucher ~\$100/family) targeted to 34% of registered HH
  - Monthly Support for NFI purchase (= 'smart card') targeted to 18% of registered HH
  - Winterization Package (= an HT blanket pp, 1 heater, plastic sheeting, fuel vouchers)
  - Strategic reserve stock of each NFI needed (min. 10,000 HH, but 30,000 desirable)
- 11 Agencies submitted their NFI plans for RRP5




# NFI-Update

## Action Points:

- Agencies agreed on a single actor / place for all assistance to newcomers & reporting the numbers there on a monthly basis
- Many agencies still to submit NFI distribution data for Jan, Feb & March
- Deadline for submission of agency plans for RRP5 is COB today !

# Rapid Estimate of Syrian New Comers in March 2013



# PROTECTION-Update

## Highlights

### **Bekaa**

Situation in Arsaal is of concern - particular security/political context continues to have a negative protection impact on refugees. Following recent kidnappings LAF have tightened procedure at checkpoints. As a result, undocumented refugees fearing risk of arrest do not move out to get registered.

### **North/Qubayat**

Detection of highly vulnerable refugees is improving in Akkar. Successful priority registration procedures allowed particularly vulnerable families to be registered within 48 hours and access to timely assistance.



# PROTECTION-Update

## Highlights

### **North/Tripoli**

Forum of the Handicap Union's premises will be as a community centre. It will serve as an extension of the community centre in El Mina SDC run by DRC and will be accessible to persons with disabilities who will be able to receive livelihood training, language classes and social activities (including recreation).

### **South**

Concerns raised about movement of Syrians within the former south "security belt"; presence of check points prevent refugees to access registration centres; It is the case of new arrivals in Cheba'a. UNHCR Tyre is analysing ways of organizing transport for these families and negotiate with the authorities a safe and unimpeded passage.



# SGBV TASK FORCE-Update

## Highlights:

- **SOPs** were validated last week in the Bekaa. 7 hubs with localized referral pathways and lead case management agencies have been agreed upon. Similar exercise planned for Tripoli, Akkar, Mount Lebanon and South.
- **Capacity-Building:** Series of SGBV Emergency Preparedness and Response Trainings is starting next week in Qobayat .
- **Information Management and Sharing:** Assessment of the GBVIMS mini-roll out was conducted this week in Akkar to look at options to expand coverage. Discussions around national information sharing protocol between members of the Task Force has been initiated in order to improve monthly statistical report and analysis.



# Child Protection in Emergencies (CPIE)- Update

## Highlights:

- Arrival of ProCap Senior Protection Officer as CPIEWG Coordinator (hosted by UNICEF)
- RRP5 – received member submissions on planned activities, target populations and budget requirements to be consolidated for CP input
- Review of sector outputs to include preventative action (in addition to response and environment building activities)
- CPIEWG meeting at **11am on Monday 8<sup>th</sup> April** at UNICEF to finalize CP input into RRP5


