Standard winterization kit & NFI winterization caseload

Standardized winterization package per selected HH consists of:

- One High Thermal Blanket or Quilt per person – cost \$10
- One stove and appropriate fuel container (gas or diesel) – cost diesel stove approx. \$100, cost gas stove approx. \$50
- Cash for fuel, at a rate of \$100 per targeted HH per month for five months (Nov-March)
- Timeline: to start implementation in October 2013

NFI winterization caseload:

- Registered refugee households, defined as vulnerable, living in cadastral area above 500m in elevation
- All occupants of ITS regardless of their registration status, vulnerability, nationality and the altitude of the ITS
- 10% of safe margin allocated to each area to cover PSN
- Projected NFI Winterization caseload **for South region: 5, 238 HH**




