Update on the RRP 6	<p>The deadline for the data entry by organisations applying for funding through RRP6 ended Sunday 13 October.</p> <p><u>The next steps will be the following:</u></p> <ul style="list-style-type: none">• Peer review in the period 22 -27 October, to ensure that i) planning assumptions have been applied coherently between sectors, ii) categorizations per output are consistent, iii) budget requirement developed by different sectors are coherent, iv) reduce duplication and ensure complementarity between related sectors and v) application of the Gender marker• Sector leads for the CP group will review the data entries and in case of any follow up needed, in particular on information missing and in relation to the categorization, the respective organization will be contacted directly before Thursday 24 October.• Several implementing partners (IPs) of UN agencies have requested to be more visible in the RRP 6. Currently, UN agencies have asked for funding on their behalf and therefore the IPs are not visible for donors or others.
