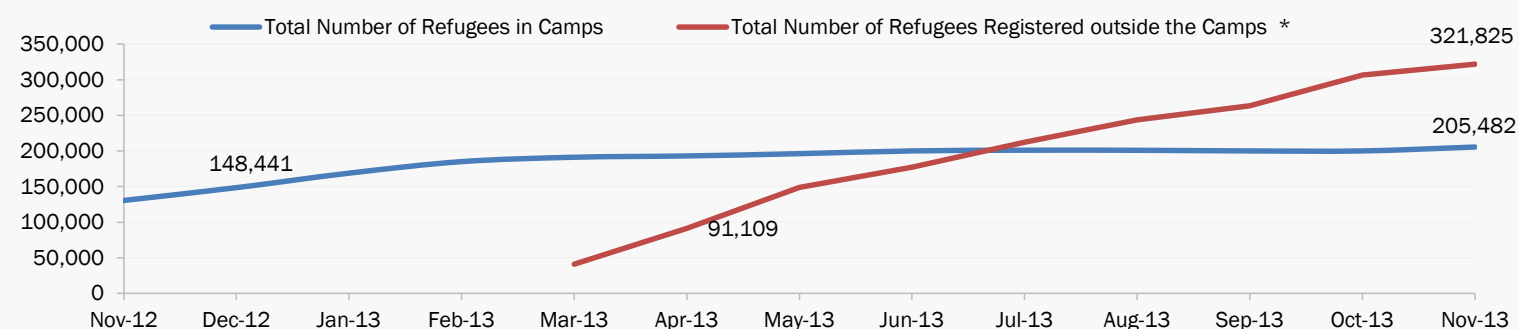

## Highlights

- On 28 November 2013, AFAD - the Disaster and Emergency Management Agency of Government of Turkey - announced that the total number of Syrians registered and assisted in 21 camps in 10 provinces was 205,482 including 104 Syrians receiving medical treatment in hospitals. AFAD reported that during the 24hrs of (27-28 Nov. 2013) 363 Syrians were admitted and registered in the camps and 279 Syrians have voluntarily returned to Syria.
- UNHCR visited the coordination center in Ceylanpinar town. Officials informed that the center was opened recently as an annex to the main coordination center in Sanliurfa city center and is using the same software (EYDAS - Electronic Aid Distribution System) for the registration of the non-camp Syrians living in Ceylanpinar town.
- The officials of the Coordination Center in Ceylanpinar informed UNHCR that the majority of the people they are registering are Syrians previously registered in Ceylanpinar camp who were not living in the camp. The officials are informing the families to approach the center for their re-registration if they still live in Ceylanpinar town and its villages. Those who are living in the areas out-side of Sanliurfa province are informed to approach the coordination centers (AFAD) in the areas where they reside.
- The registration unit in Ceylanpinar camp informed UNHCR that as of 28 Nov. 2013, almost 80% of the camp residents are registered within the new software provided by the Ministry of Interior (MOI). Reportedly they are having technical challenges that slows down the registration process. Reportedly when the renovation in the camp is completed, the new ID cards with biometric data will be used for entrance and exit from the camp. The food distribution system will also be switched to an e-card system and an amount of 80 TL per person per month, financed by AFAD and the local governorate.
- The camp management in Ceylanpinar stated that they are also having spontaneous arrivals approaching directly to the camp and these new-comers are provided accommodation in the waiting tents (rub halls) until they are provided family tents. The officials informed that during the renovations in the camps, two small districts in the camp will be merged to gain more space. Reportedly in each renovated district about 50 more tents are established in order to absorb those who are in the waiting area (rub hall tents). During the waiting period these people are also registered in the camp records, provided food and have access to all services in the camp.
