

N/A (non-applicable) Coding Guideline:

The IASC Gender Marker is a tool that codes, on a 2-0 scale, whether or not a humanitarian project is designed to ensure that women, men, boys and girls of all ages will benefit equally from it, and that it will contribute to increasing gender equality.

Humanitarian assistance must meet the distinct needs of women, girls, boys and men of all ages to generate positive and sustainable outcomes. However, some projects respond to a *humanitarian support need only*, never coming into contact with affected populations or having any influence over resources, goods or services provided to affected populations. Rather than coding such projects as '0', with the implication that they are insensitive to gender issues and differences, a new code has been developed. The Code N/A, or Not Applicable will be used to indicate that integrating gender in such a project would not affect the project's outcomes or sustainability. These projects fall primarily under support services and/or logistics, and may include air support services, procurement, emergency telecommunications. However such projects may fall within the domain of any cluster. Three criteria must be met for a project to qualify for the N/A code:

N/A CODING CRITERIA

- ✓ The project does not have any **direct contact** with affected women, men, boys or girls;
- ✓ The project does not **directly affect** the choice of resources (goods/services) that will be available to women, men, boys or girls;
- ✓ The project does not **directly affect** the methods by which resources (goods/services) will be accessed by women, men, boys or girls.

ALL THREE CRITERIA MUST BE MET FOR A PROJECT TO QUALIFY FOR THE N/A CODE

Examples of N/A coded projects might include:

CLUSTER	PROJECT EXAMPLES
Emergency Telecommunications	To deploy new radio room hardware to ensure MOSS compliance
Logistics	To provide air transport for humanitarian staff
Logistics	To preposition mobile storage units for rapid deployment

<p>CODE 0</p> <p>No visible potential to contribute to gender equality</p> <p><i>Gender and age are not reflected anywhere in the project sheet or only appears in the outcomes.</i></p>	
<p>CODE N/A - NOT APPLICABLE</p> <p>This project does not have direct contact with affected populations, including their employment, and does not directly affect or determine the selection or use of resources, goods or services accessed by affected populations.</p>	
<p>CODE NOT SPECIFIED</p> <p>This project is still in development and the Gender Marker code is temporarily not specified.</p>
