



Basic Needs Assistance (cash and in-kind) by end January 2016:

- 223 households received Basic Needs Assistance (Core Relief Items)
- 15,459 households received 2nd round winter fuel support(200 liters/household).

JANUARY HIGHLIGHTS:

Winter support to Refugees across KR-I both in and out of camp continued in January with the start of the second round of kerosene distribution of 200 litres per household intended to provide heating for January and February.

A total of 15,459 households received winter fuel support during the month:-

Dohuk:	3139 HH in-kind kerosene in camp UNHCR
	2769 HH in-kind kerosene in camp German Red Cross
	1600 HH cash for kerosene out of camp UNICEF/Tearfund
Erbil:	6065 HH in-kind kerosene in camp UNHCR
Sulimaniyah:	1569 HH in-kind kerosene in camp UNHCR
	317 HH in-kind kerosene out of camp UNHCR

223 Core Relief Items (CRI) kits were distributed to newly arrived families or newly married. A further 1561 households received specific items as replacement for old or damaged CRI as support to reunified families. In addition NRC distributed underclothes to 1300 women in Kawergosk camp.

Distribution of winter fuel assistance is expected to be completed during February both in and out of camps

NEEDS ANALYSIS:

Sulimaniyah:

Sulimaniyah is experiencing electricity cuts which will affect the protection and well-being of the Syrian refugees, particularly those residing in camp that does not have access to backup generators. This also affects the water supply as the pumps also require electricity. A solution is required as a minimum to ensure continuation of the water supply.

Erbil:

Some residents of Basirma have departed the camp either heading back to Syria or on to Europe without notifying either UNHCR or the camp administration. Evidence suggests that they are passing on their UNHCR certificates to relatives who in turn use them to receive benefits and services. This has specifically presented a problem when identifying households to receive kerosene distribution.

Dohuk:


Reports an on-going requirement for fire extinguishers in all refugee camps as well as a fire truck for Domiz2.

Hygiene kits in all camps 216 trash bins in Domiz2 and construction of shading at distribution points for none camp refugees.

Dohuk also reports that feedback from refugees is informs that they prefer multi-purpose cash assistance rather than in kind support due to the travel costs involved.

There is also a general comment from all governorates about the quality of distributed stoves.
