### 1. Introduction

- Friday the 16th of October is the deadline for the draft of the sector docs for the LCRP 2016 Revision (Sector Strategy, Log Frame, summarized budget)
- The core group met twice to update the log frame and the strategical shifts

### 2. LCRP 2016 Revision (Shelter Sector)

1. Finalization of the results framework: 9 outputs, results, indicators by the core groups, in coordination with the working group members
2. Targets are disaggregated by population cohort, institution and governorate.
3. Budget for each output is discussed with core group and agreed on realistic budgets
4. Partners will express their interest in contributing to reaching output targets by ticking the type of activities they plan to implement in 2016. The activities in the planning database will come from the results framework. Activity level is published in the LCRP log frame, disseminated after this meeting
5. List of partners by output is extracted from the planning database (ActivityInfo) and compiled with budget by output in final sector submission.

*Deadline for the above is **October 16, 2015** when the complete sector chapter is submitted to the CPT for review.*

- PRS/ PRL cohorts will be targeted in the shelter strategy
- UNHCR did a verification exercise ; 75,000 Households (on base of UNHCR registration platform)
- Each sector is required to provide an estimate of the most vulnerable – in need targeted cohort ( needs-based approach)
- The number of registered SyR. has stabilized to 1.1 M
- Today, the vulnerability selection criteria are based on the 75, 000 HHs visited. However, the strategy in 2013-2014 was based mostly on the phone survey.



- The activity regarding collective centres has been slowed down due to high costs
- “Tenure security” : Number of lease agreements needs to be reported under the shelter log frame - but general information /awareness rising on lease shall be reported under the protection WG
- There are no semi-formal tented settlements anymore, the URDA camps have received formal status with coordination between the Ministry of Interior (Mol) and Ministry of Social Affairs (MOSA)
- “Neighbourhood upgrading” for the shelter program indicator will be included in the 2016 shelter log frame ( multi-sectoral activity)
- A meeting should be held soon to define the neighbourhood approach activity and agree if it should be reported under the social stability or shelter sector
- Priority of targeting goes to the socio-economically highly and severely vulnerable HHs ; however , the overall target is for all the people in need of shelter assistance (people in substandard shelters)
- No need for disaggregation for site improvement activities
- UNRWA : 75,000 PRL living inside the PRL camps and gatherings are in need of shelter support
- The Shelter Sector will not promote an activity on discussing / elaborating a housing policy since it was an activity in 2015 that was never reported on.

**Next steps:**

- The Narrative and the Budget will be shared to the Shelter Core WG for comments. The average unit cost per activity will be agreed on by the core group (incl. overhead average per activity)
- The Nat. Shelter Sector will share the updated log frame to all partners for inputs and comments before the submission at the end of this week

### 3. Updates from the field offices

#### North (T+5 and Akkar)

- Winterization - Technical assessments for WPK distribution in IS/SSB finalized. Site improvement assessment ongoing  
Total number of assisted Households in T5+Akkar will reach 13.788 with WPK in IS and SSB
- CS Rehab – UNHCR funded rehabilitation program ongoing in occupied and unoccupied units
- ✓ 2015 Target for occupied: 200 HHs (73 achieved) – UNHCR funds
- ✓ 2015 Target for unoccupied: 428 HHs (290 achieved) – UNHCR funds
- \* Problems with some municipalities reported by partner in Koura and Batroun districts
- Cash for Rent - 250 HHs targeted the last month

##### *Winterization Activities*

- Focused effort on winterization activities in Informal Settlements for flood-risk mitigation, rain water disposal, & isolation from weathering elements drainage water provision: namely in IS Choueifat, Jiyeh, Ketermaya, Hadchat. (Baabda, Aley, Chouf & Keserwane).

##### *MFT Monitoring*

- Partners' Performance Monitoring visits was conducted with a MFT respectively with both Shelter/WASH IPs [PU-AMI & CHF]. Following outputs were examined: SoKs distribution and their different uses in informal settlements, SSU rehab (different modalities), latrines, water tanks and water filters' distribution & use.

##### *CS Maintenance*

- The contractor for the MR / maintenance of 4 CS [Fonar CS, Oqaipe CS, Baabdat CS, Hrajel CS] has been selected and signed the contract.

##### *LCRP Revision*

- Meeting with National Shelter WG to discuss LCRP 2016 revision. [CHF / PU-AMI / ACTED]
