DISCUSSION

1. TOR and Workplan 2015

- The group reviewed the FSS TOR and agreed that the chair will revise the TOR to include a section on the role and responsibility of the co-chair, following which the updated version will be circulated with the group via e-mail for feedback
- The group also reviewed the 2014 workplan in order to identify activities which have been achieved and activities which continue to apply, in addition to new activities for 2015.
- The following key areas guided the workplan discussion: strengthen coordination, capacity development, planning and strategy development, advocacy and resource mobilization, information management, monitoring and reporting, protection and gender mainstreaming.
- Cross-Sector Coordination was also discussed in light of the Inter-Sector Working Group (ISWG) 2015 workplan, primarily focusing on linkages with the following sectors/Working Groups (WGs) and networks: Basic needs WG, Protection WG, Prevention of Sexual Exploitation and Abuse (PSEA) group, Sector Gender Focal Points Network (SGFPN), Nutrition sub-WG, Education WG and the ISWG.
- Among the several issues discussed, WFP shared that a second Comprehensive Food Security Monitoring Exercise (CFSME) is planned for next month and will be addressing the different food insecurities for women, girls, boys and men. Correlations between gender and family size will be a main area of focus.
- It was agreed that the chair will edit the revised workplan and circulate via e-mail to the larger group for feedback.

2. Jordan Response Plan (JRP) Approval Modalities

- MoPIC/JRP Secretariat circulated a message regarding the new JRP approval modalities. Projects that fall under the JRP can now be submitted to MoPIC for approval. Submissions should be made according to **JRP Project**
