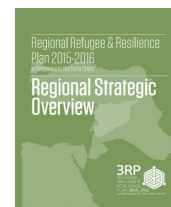

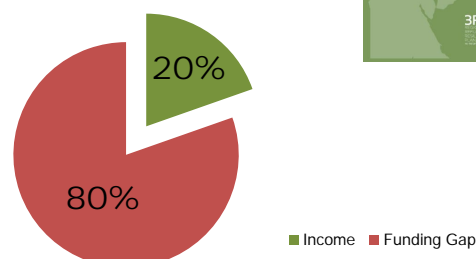
## 3RP REGIONAL REFUGEE AND RESILIENCE PLAN
