<b>1. Mercy Corps</b>	<ul style="list-style-type: none"> <li>• Locations and number of beneficiaries: <ul style="list-style-type: none"> <li>- Lesvos (Kara Tepe, Moria, PIKPA, CARITAS) – full site coverage minus UASC</li> <li>- Kos (hotspot, ASpa, Zikas) – full site coverage minus UASC</li> <li>- Leros (PIKPA and Lepida) – dull site coverage minus UASC</li> <li>- Western Greece and Athens: Filipiada, Doliana, Tsepelovo, Lavrio , Malakasa, Agios Andreas, Ritsona (waiting for IRC confirmation), Konitsa, Katsikas, Athens urban (TBC), Rafina and Elefsina (not started yet) – full site coverage minus UASC</li> </ul> </li> <li>• Duration: 3 months on islands (September to December 2016), NW (from now until November – ECHO), Attica now to March 2017</li> <li>• Frequency: every month</li> <li>• Start date and end date: July/ August until November/ December 2016</li> <li>• Donors: ECHO, private donors, Google, Apple, Microsoft</li> <li>• Delivery mechanisms: prepaid cash cards (ATM and POS)</li> <li>• Communications 'every month distributions', explanation/ info session of delivery mechanism</li> </ul>
<b>2. CRS</b>	<ul style="list-style-type: none"> <li>• Locations: Skaramangas, Schisto, Athens sites and urban sites (TBC) – for UNHCR relocation programme</li> <li>• Beneficiaries: full sites about 3,000 people (pre-registered only)</li> <li>• Duration: TBC if there is funding until end of year</li> <li>• Frequency: every month</li> <li>• Start and end date: August 2016 until (possibly) December 2016</li> <li>• Donor: DFID, UNHCR</li> <li>• Delivery Mechanism: prepaid cash cards, ATM + POS</li> <li>• Communications: yes being done prior to distributions, need to harmonize</li> </ul>
<b>3. Samaritans Purse</b>	<ul style="list-style-type: none"> <li>• Locations: still unclear possibly Chios and/ or Athens urban locations (TBC)</li> <li>• Beneficiaries: TBC (pre-registered only)</li> <li>• Duration: 3 months</li> <li>• Start date: September 2016</li> <li>• Donor: private donors</li> </ul>

	<ul style="list-style-type: none"> <li>• Delivery mechanisms: vouchers and POS machines only</li> <li>• Communications: TBC</li> </ul>
<b>4. UNHCR Relocation</b>	<ul style="list-style-type: none"> <li>• Locations: Mainland – Athens, Thessaloniki and Lagadikia</li> <li>• Beneficiaries: 2,200 people – relocation eligible nationalities only (pre-registered)</li> <li>• Duration: ongoing for 2 years</li> <li>• Start date: February 2016</li> <li>• Donor: DG HOM</li> <li>• Delivery mechanisms: prepaid cards, some vouchers, some cards POS restricted only</li> <li>• Communications: yes delivered through partners</li> </ul>
<b>5. UNHCR MPG</b>	<ul style="list-style-type: none"> <li>• Locations: starting with sites in mainland where UNHCR was given lead SMS role (plus urban and islands TBC) using MOMP list</li> <li>• Beneficiaries: 15,000 (pre-registered only)</li> <li>• Duration: until March 2017 but with plans for December 2017 and as needed</li> <li>• Start date: October 2016 (tendering FSP)</li> <li>• Donor: ECHO (TBC)</li> <li>• Delivery Mechanism: prepaid cash cards (ATM + POS)</li> <li>• Communications: yes, still in draft format and CONFIRMING with CWC and SMS <ul style="list-style-type: none"> <li>- Cash assistance is starting now throughout different places in Greece</li> <li>- Cash assistance is being provided by different agencies at the moment</li> <li>- Cash assistance cannot be provided at all places at the same time</li> <li>- Cash assistance will be provided to all locations in Greece for pre-registered AS/ POCs</li> <li>- Cash assistance will not be provided to people outside their current place of residence</li> <li>- Please do not try to move to another site where cash is being distributed, as you will not be provided with cash assistance unless you live in this site</li> <li>- Mainland is being prioritized but negotiations are ongoing for the islands/ hotspots</li> <li>- Please be patient, everyone who is pre-registered with an Asylum Seeker card will be serviced with cash assistance</li> </ul> </li> </ul>
<b>6. IFRC</b>	<ul style="list-style-type: none"> <li>• Locations: Ritsona, Skaramangas (arrangement with CRS), Diavata, Nea Kavala, Oreokastro, Herso, Softex/ Kordelio</li> <li>• Beneficiaries: 3,500 heads of households – 17,500 people in total (pre-registered) plus 875 heads of households for poor Greeks</li> <li>• Duration: 4 months</li> <li>• Start date: September 2016 (tendering FSP)</li> <li>• Donor: ECHO</li> <li>• Delivery mechanisms: prepaid cards, some food in-kind (this TBC/ might need to change for all cash at the request of the CWG)</li> <li>• Communications: not yet, but planned</li> </ul>
<b>7. IRC</b>	<ul style="list-style-type: none"> <li>• Locations: Eleonas 1, 2 and 3 plus North (Giannitsa, Alexandria, Diavata, Veria) and Attica (Schisto + Skaramangas – if no overlap)</li> <li>• Beneficiaries: 3,300 people (pre-registered only but looking to expand to not pre-registered only)</li> <li>• Duration: 4 months</li> <li>• Start date: August 2016</li> <li>• Donor: ECHO and others</li> <li>• Delivery mechanisms: prepaid cards, Visa card and SWIFT</li> <li>• Communications: yes prior to cash cards distributions</li> </ul>
<b>8. UNICEF</b>	<ul style="list-style-type: none"> <li>• Coming in as observer, seeing what needs to be covered and contributed particularly for children UASC etc. No plans yet.</li> </ul>

<b>9. CARE</b>	<ul style="list-style-type: none"> <li>• Locations: Athens and Thessaloniki (urban)</li> <li>• Beneficiaries: 350 people and 250 people respectively</li> <li>• Duration: 6 months (until March 2017)</li> <li>• Start date: September 2016</li> <li>• Donor: ?</li> <li>• Delivery mechanism: ideally single card platform provided by UNHCR, if not sooner vouchers until then</li> </ul>
<b>10. Oxfam</b>	<ul style="list-style-type: none"> <li>• Locations: Epirus, Konitsa, Tsepelovo, Doliana, Katsikas, Filipiada (Yazidis accommodation) – after Mercy Corps finishes distributions</li> <li>• Beneficiaries: 1237</li> <li>• Duration: 4 months</li> <li>• Start date: October or November 2016</li> <li>• Donor: ECHO</li> <li>• Delivery mechanism: cash cards, prepaid, Swift</li> </ul>
<b>11. DRC</b>	<ul style="list-style-type: none"> <li>• Locations: Elliniko 1, 2 and 3, Skaramangas, Volos and Koutsochero (willing to change if this overlaps with other agencies)</li> <li>• Beneficiaries: ?</li> <li>• Duration: ?</li> <li>• Start date: ?</li> <li>• Donor: ECHO</li> <li>• Delivery mechanism: ?</li> </ul>
