#### 4. UNFPA New Strategic Plan for 2018-2022

**UNFPA GOAL (Bulls Eye):** Achieve universal access to sexual and reproductive health, realize reproductive rights, and reduce maternal mortality to accelerate progress on the International Conference on Population and Development (ICPD) agenda

- **The human rights of women include their right to sexual and reproductive health**
- **Family planning is an investment not an expenditure**
- **When women are healthy and have choices, they are a vehicle for economic development.**

➤ **Outcome 1:** Sexual and Reproductive Health and Rights

(Every woman, adolescent and youth everywhere, especially those furthest behind, have fully exercised their reproductive rights and used sexual and reproductive health services free of coercion, discrimination and violence.)

- **Output 1:** Enhanced capacities to develop and implement policies, including financial protection mechanisms, that prioritize access to SRHR information and services by those women, adolescents, and youths left furthest behind, including in humanitarian settings
- **Output 2:** Strengthened capacities in delivering quality integrated family planning, comprehensive maternal health and STIs and HIV information and services, in particular for adolescents and youth and in humanitarian settings
- **Output 3:** Strengthened capacities for improving human resources for health management and skills, especially for midwives, to deliver quality and integrated SRH services, including in humanitarian settings
- **Output 4:** Strengthened capacities to effectively forecast, procure, distribute and track the delivery of SRH commodities, including in humanitarian settings

➤ **Outcome 2:** Adolescents and Youth

(This will focus on strengthening international and national commitment to investing in adolescents and youth, particularly adolescent girls, in a broad range of sectors, equipping young people with the skills and knowledge they need for their sexual and reproductive health and rights, and giving them a voice in matters that affect their health and well-being.)

**6. Agency Update:**

**JHAS:**

- RH kit 3 provided by UNFPA was received for clinical management of rape.
- Working on neonatal care services and in the process of procurement for 2017 and approval was received.
- Collaboration on community health projects and psychosocial support with IRD and IFH
- Within the RH SWG ,UNFPA requested partner to provide their needs of Depo-Provera injectable Family planning method as there is a stock with other NGO's that need to be utilized before the end of 2017

**HSD:**

- Working with MoH and now HSD developed a technical working group in order to work on the development of RH maternal, neonatal and child health messages that will used by the primary health centers providers and outreach program.
- The outreach program will start by next year as the counselling curriculum will be prepared by OCT
- With collaboration of Women and Child health directorate a new approach was tried for training physicians on Implanon services
- Trained 6 health centers in Irbid with on job training approach.
- Developed client file for NGOs by working with IFH and JFPP
- MoH agreed to provide IFH with children's files to be used at the moment
- HSD will develop at the health centers level a station (client service station)the station will track the clients approaching the health centers and identify what services are being requested by the clients

**MEDAIR:**

- Cash for health program was paused for the referrals due to high numbers of referrals.
- The program may run back as normal within weeks

**JICA:**

- Finalizing village health center manual with collaboration of MOH
- Working in Irbid and Mafraq to operate the mobile clinic and now in the registration phase to be registered with MoH

**SCJ:**

- SCJ last working day in camps was 8th Jun
- SCJ trained IMC- JHAS as the part of the hand over process in the camp as agreed earlier.
- All materials and data were shared with IMC and JHAS.
- SCJ department of health and nutrition will continue running for the coming months

**UNHCR:**

- UNHCR working in Bill Gates fund project and now hiring new consultant for emergency obstetric care and will be doing the major obstetric care topics for JHAS and IMC staff in Zaatari & Azraq
- Still working on the training schedule and will be for camps only

**NWHCC:**

- NWHCC have a comprehensive health care center in Tafileh
- Working with UNFPA on RH SOPS to be generalized on all RH services in Jordan
- Now in the printing and designing phase of the SOPs
