<p>During the previous monthly meeting of June 2017, it was already agreed that all Sector Gender Analysis would be completed by the end of July. The Chair will follow up on the progress by sending reminders to remaining sectors.</p> <p>The Government of Jordan started the JRP planning phase. In July – August, JRP Task Force meetings will be organized for respective sectors. According to the calendar, JRP Task Forces will draft Comprehensive Vulnerability Assessment, Sector Response Strategy and Project Summary Sheets.</p> <p>It would be beneficial to reflect findings of Sector Gender Analysis in the JRP Comprehensive Vulnerability Assessment and Sector Response Plan documents.
