Information management update (Activity info vs Service advisor)	<ul style="list-style-type: none"> - UNHCR Information management presented updates regarding the status of partners reporting using activityinfo and services advisor. - Activity info is an online database that allows partners to report their achievements based on pre-set indicators adherent to the JRP structure. It allows humanitarian organizations to access, manage, map and analyse indicators, and thus to monitor humanitarian projects. - Services Advisor is a tool that provides up-to-date information about availability of humanitarian services. Services Advisor allows users to view available services on a map and in a service directory, where they can filter by sector, governorate, services provider and referral requirements. - Sixteen partners reported their monthly achievements on activityinfo and only six partners added their projects information and referral pathway on services advisor. Partners are encouraged to reflect their projects in services advisor as its being used by the helpline and case managers for referral. - Information management team is willing to support partners is utilizing the information management tools. partners in need for support are encouraged to contact Gorgui Diouf (dioufg@unhcr.org)

Presentation on the Basic Needs gender analysis	<ul style="list-style-type: none"> - Basic needs sector gender focal point (SGFP), Sana Qasmieh form (ACTED) and Ruba Saleh form (UNHCR), presented the finding of the Basic Needs gender analysis that have been produced with the support form a Basic Needs gender analysis team consisting of IRC, DRC , NEF and UNWOMEN. - The presentation covered objective of the gender analysis, methodology, findings and recommendations. The gender analysis reflected the notable changes in the traditional roles of women and men at household levels. Women are more empowered and men are getting supportive and understanding of increasing involvement of women in the public life. - The gender analysis will be shared with the BNWG members for their review. Standard Operating Procedures for Coordinated Needs Assessments	<ul style="list-style-type: none"> - The inter-agency coordination unit presented the standard operating procedures for Coordinated Needs Assessments.
