UNOCHA visited the camp and monitored camp situation on 6th April. LWF d Regional Representative Mr David visited camp with 3 visitors and discuss with CMC, WDG, PTA and FMC participate by 20 (12 women) for camp situation on 7th April. LWF replenished 5 Complaint Response IEC billboard on 5th April and installed shelter label 285 Longhouses on 27th April. One of IDP women (LHN 33, RN 7) died due to high water wave while collecting firewood near the sea on 19th April. Camp level Inter-Agency Meeting (IAM) was held and participated by 30 (13 women) representatives from CMC, CDN, FMC, WDG, Youth Development Group-YDG), DRC and LWF on 27th April. 5 (4 girls) babies were born and 5 women pass away during the month and updated population sheet. 	<ul style="list-style-type: none"> Two letters received by LWF through complaint box one is about unfair prize and next one is information on women death by high wave on 20th April.
