

#### Notes

- 1. The financial requirements of the Venezuela Situation include requirements in Brazil, Colombia, Costa Rica, Ecuador, Mexico, Panama RO, Peru, Trinidad and Tobago, United States of America and Venezuela. The total figure includes support costs.
- 2. The percentage funded is calculated using earmarked contributions pending the eventual allocation of broadly earmarked and unearmarked contributions.
- 3. Contributions are shown by the level of flexibility in the earmarking. Contributions earmarked to a situation within a country are classificated as country level.
- 4. The broadly earmarked contributions listed are those which can potentially be used for the Venezuela Situation due to their earmarking to a related region, sub-region, country or theme. The total amount of the contributions is shown for donors who have contributed \$2 million and more.
- 5. The total amount of unearmarked contributions is shown for donors who have contributed \$10 million and more.
