## Pakistan: Afghan Refugees Registration Update | 1 January – 30 June, 2019





# Overview

The Proof of Registration (PoR) card is an important protection tool that is issued by Government of Pakistan and provides temporary legal stay and freedom of movement for the 1.4 million registered Afghan refugees in Pakistan. All the PoR cards that expired at the end of 2015 have been extended through official notification until 30 June 2020\*.

The four PoR Card Modification centres (PCM) are located in Peshawar, Quetta, Karachi and Rawalpindi. These centres are used for the modification and replacement of existing cards; the registration of infants and children up to the age of five years; the issuance of new cards for eligible children who are five years and older; and the issuance of birth certificates to children under the age of 18.

In 2019, UNHCR prioritised funds for birth registration and the issuance of birth certificates to 70,000 children. The target for the issuance of individual PoR cards is 170,000 children who have reached five years of age and are eligible to receive their individual cards from the PCM centres.

In June, a significant increase in the number of persons approaching PCM services was observed. During the reporting month some 4,812 persons benefited from registration services (217% increase compared to May 2019). The resumption of Mobile Registration Van (MRV) operations in all three provinces after Ramadan is attributed to the increase.

\*PoR cards have been extended until **the end of June 2020** by the Federal Cabinet in its meeting of 27 June 2019.

\*\* The issuance of birth certificates is temporarily suspended by NADRA HQ. UNHCR is following-up with NADRA HQ to resolve the issue on a priority basis.











### Card modification / replacement



Cards modification includes changes to Name, Father Name, Gender and Marital status and it does not entail an annual target.

The following charts summarise the progress towards 2019 targets and the remaining gaps.

The percentages for birth registrations, birth certificate issuance and provision of PoR cards to registered children that have reached five years of age are based on the estimates noted on page 1. These overall targets have been apportioned to each centre based on the size of the Afghan refugee population for which the centre provides services.

During the reporting period, the trend in child registration activities increased significantly compared to those in May 2019 at all PCM centres and MRVs countrywide (a total of 1,937 children were registered in June 2019 at all the PCM centres and MRVs countrywide compared to 456 in the month of May 2019).

In 2019, based on a cost-benefit analysis with PCM centres and discussions on the best interests for persons of concern, UNHCR will continue to deploy 3 Mobile Registration Vans (MRVs) in KP, Balochistan and in Punjab (for a period of four months each). The deployment of MRVs was very successful in 2018. The Mobile Registration Vans provide services for applicants living in remote areas of KP, Punjab and Balochistan, facilitating those who can't afford to travel to PCM centres.

During the month of June, the Mobile Registration Van (MRV) operations resumed in Punjab and Balochistan provinces. The MRV operations also commenced in KP province in June and will continue until the end of November 2019.

During the reporting period, birth certificate issuance remained temporarily suspended by NADRA HQ. The reason of the suspension is that NADRA HQ has made changes in the template and they are seeking formal endorsement from the Ministry of Interior/CCAR. UNHCR is following-up with CCAR/NADRA HQ to resolve the issue on a priority basis.

It should be noted that the trend for PoR card modifications will naturally follow that of birth registrations and the provision of PoR cards to children over five. This is because children are added or removed from their parents' cards, and their parents' cards will need to be modified.

From 1 January to 30 June 2019, 3,219 lost or stolen cards were replaced. Deaths of refugees continue to be significantly underreported. Only 15 deaths were registered/reported between January to June 2019.
