Feedback from field- based CP SWG coordination structures	 Current field-based contact list will be circulated asap with all members; Amman/ South CPSWG structures have been under discussion with relevant chairs of coordination groups; in absence of a dedicated CPSWG coordination structure, ad interim, UNHCR Amman/ South staff will represent CPSWG related concerns and follow up on Information Management and CM structures; further discussion on the Amman/South coordination to be held; Mafraq Coordination: plan to establish a CP SWG which shall be merged with the recently established SGBV SWG; current review of Referral Pathways is ongoing and to be finalized soon; Irbid: was not present at national CPSWG meeting; Increase of CP actors in Irbid governorates triggered recently a coordination structure was established for case coordination and referrals of CP and SGBV cases (chaired by UNHCR); updates to be received regularly; Azraq SWG; completing gap analysis drafting as well as other IM tools (5Ws, Referral Pathways); child labour will be addressed in some of the upcoming CPSWG meetings in Azraq and knowledge of IMC and UNICEF who worked extensively on an improved system of knowledge generation will be presented; another topic of concern is the current alternative care project in Azraq camp that was suggested to be presented at one of the SWG meeting at national level; Zaatari Camp: IMC is no longer chairing the CPSWG in Zaatari that was jointly held with the SGBV actors under the leadership of NHF; current role as co-chair was taken over by UNHCR until selection of a co-chair is finalized in June; current work relates mostly to the finalization of the gap analysis; reviewing inter-setoral linkages and prevention activities on child labour; next SWG will be done jointly with the Youth TF in ZC and will address child labour as well as sexual harassment; 	•	Co-chairs finalized the list of current focal points in the different locations, see attached Field-based SWG chairs/ co- chairs are encouraged to attend regularly the national SWG meeting and to brief on changes, activities and challenges on coordination;		UNHCR

RF presentation on the Youth Camp	 JRF Youth volunteer from Sudan presented their youth-focused project: youth empowerment project (thorough selection process – this year 700 youth applied for the youth camp) Component consist of three main activities: Youth Peer Educators Training: total number of 20 youth (10 in Amman, 4 in Karak, and 6 in Aqaba), ages between 18 – 25, attended a 5-day training camp that focuses on a number of topics, not limited to: youth-friendly communication and engagement skills; child protection concepts; needs assessment techniques and approach; facilitation skills; team building, and child development. Following, the youth will conduct a basic assessment targeting a total of 120 adolescents (40 Amman, 40 Karak, 40 Aqaba), and 60 parents (20 Amman, 20 Karak, 20 Aqaba) to identify and discuss the main Child Protection concerns based on which the youth groups are provided with support to establish tools to address those concerns/ risks; before developing the tools, selected youth undergo a specialized workshop for the period of 3 days, on different topics, including: Training on youth-friendly tools, project development; quality of tools, planning for quality- testing; evaluating and modifying the tools. The tools will vary between mobile applications, interactive protection games, and others. A final workshop in which the youth will present their tools will be facilitated.
