<u>Introduction and welcome:</u> Partners introduced themselves and gave a brief overview of their respective education programs.		
<p><u>JRP 3 pillars updates: Access, Quality and Systems Strengthening:</u></p> <ul style="list-style-type: none"> • Access, Quality and System Strengthening: <p>MoE, DoE and partners delivered formal, non-formal and informal education in camps and host community with the following details:</p> <ul style="list-style-type: none"> ➤ Access: As of Sep, partners provided access to 2,942 children with non-certified ECE program, 11,571 with certified Non-formal education (NFE) and 97,739 children with learning support services. ➤ Quality: 4,288 teachers, facilitators and school staff were trained on PSS and child-centered approach and life-skills. ➤ Formal Tertiary education reached 337 scholarship opportunity provided university and post basic education. <p><u>Update on JRP process:</u></p> <p>Taskforce members (UNHCR, UNICEF, UNESCO, NRC, PI, RI, FCA and QS) reviewed the vulnerability assessment last year and the PSS sheets and updated the baseline from Activity Info DB. At the request of MoPIC and MoE, the TF maintained the same budget for 2019 with a slight decrease in some areas, based on the guidance of (MOPIC). The PSS is expected to be completed with MOPIC next week.</p>		
<p><u>Update on ESWG planning process:</u></p> <p>ESWG held three meetings to discuss the planning process for 2019 and beyond. The group conducted a situation analysis and reviewed funding. Groups discussed the current situation and the future, and began to discuss the theory of change (in 2019 and beyond, what are the priorities of the program).</p>		

<p>The major outcome from the planning process is how to align the ESWG with the MoE's ESP and shift from a focus on the Syrian refugee response to countrywide development response in support of the MOE.</p> <p>Among the concerns that have been addressed is that if we try to align with ESP, it may mean that some of the current programs will be removed.</p> <p>A summary of the three sessions will be developed and shared.</p>		
<p><u>AOB :</u></p> <p>Child Protection update: A workgroup comprised of ESWG and the CP SWG has been working on recommendations to address violence in schools. The final recommendations will be shared once completed.</p> <p>CPWG developed a referral pathways document to determine referral focal points in various sectors and governorate.</p> <p>UNICEF: Partners can report Violence in school cases to Ms. Sheeraz AlMukhaime (salmukhaimer@unicef.org), and copying Ms. Suzan Kasht (salmukhaimer@unicef.org).</p> <p>FTS: UNHCR is collecting updates on the funding received (from Non-UN sources) by organization for the THIRD quarter of 2018, as well as any possible corrections for previous quarters.
