1. Compact for Young People in Humanitarian Action

UNFPA and NRC presented on the Global Compact for Youth in Humanitarian Action, which was presented at the World Humanitarian Summit, and the vision to localize the Compact in Jordan. Youth is a cross-cutting topic, which requires specific type of programming, and based on the global initiative, there are 5 actions to be undertaken to mainstream youth in all sectors. An invitation was made to the members to express interest to participate in the joint efforts to pursue localizing the Compact in Jordan.

A need to put in place the means and mechanisms to implement the Compact at the operational level was raised, and a concept note on the initiative was requested to the presenters for further discussion. Any action taken regarding localizing the Compact should be part of SGFPN strategy.
