- UNHCR MCAP validation was completed with a no-show rate of 3%. The distribution for the cards will occur in the week of October 7.
- GRM claims collection is ongoing. For the North, more than 8,000 GRM claims were collected since September 11th.
- WFP MPC and Food validation through Liban Post/ Cash United shops is ongoing.
- The first upload for the new caseload would be on November 5th.
- Discontinued MCAP/ MPC/ Food cases have received their last upload on October 5th.

Shelter

- Weatherproofing in Informal Settlements:
- Weatherproofing assessment in Informal Settlements is finalized for all Informal Settlements in the North. Data is being cleaned and analyzed.
- Cash for Rent:
- New partner for CFR: IOM (146 HH)
- New CFR partners in T5: IOM and PU-AMI (70 HH). Referrals will be handled through the sector.

WASH

- Sanitation Guidelines in ISs should be validated within 2 weeks
- End of year WAP sweep will be completed by the 9th of December and prioritization of sites located near the rivers for on site treatment as per the guidelines recommendation.

 Follow-up meeting organized by PWG and Social Stability WG to discuss harmonization of practices relating to support costs for participants in community based initiatives



SGBV


- IRC continued in the North its SGBV Peer to Peer coaching programme with the LGBTI rights and responsive mechanisms
- DRC conducted two sessions of Safe identification and Referral training to 12 non-SGBV partners in the North
- 45 new cases referred to and through UNHCR, 17 opened ones followed up

GBVIMS Trends



Sex of Survivor: 92% Female and 8% Male

Age Group of Survivor:

Adult (18 and Over): 86%

Child (below 18): 14%

Most type of incidents reported remains:

Physical Assault: 36% and Psychological/Emotional Abuse: 34%

Case Context:

- Sexual Violence: 16%
- Early Marriage: 6%



Child Protection

- Most of the LCRP targets for 2019 are almost reached in both Akkar and the North in terms of Case management, Community Based PSS, Focused PSS, community engagement and parenting support.
- ICRC presented the medical services that they can provide to any injured affected directly or indirectly by the war after 2011, and actors agreed on the referral mechanism needed for these cases.
- War Child Holland will start implementing a mental health and PSS activities for children between 10 and 14 year, they will be collaborating with actors working in Sahel area to implement this project.
- Actors were informed about RAIS use that will start soon as a tool for referral, a presentation will be delivered in the next meeting.
- The next meeting will take place on October 22nd 2019 in Tripoli.

Key & Important Updates:

Official list of 2nd shift schools for the scholastic year 2019-2020:

- 44 public schools will be operating in the North governorate; 2 schools have been closed from last year's list, while 5 new schools have been opened.
- 43 public schools will be operating in Akkar governorate; 1 school has been closed from last year's list, while 1 new school has been opened.

In total, 93 public schools will be operating as second shift schools across North and Akkar governorates.

Please note that SoPs are still not finalized; SoPs will be shared once circulated by PMU/MEHE.

The dates we have confirmed for now are the following:

- 1st of October first registration day for 2nd shift.
- 9th of October classes will start for Cycle 1, 2 and 3 (grade 1 till grade9).
- 16th of October classes will start for Prep-ECE classes.

UNICEF Expression of Interest:

- Education, deadline was on 04 Oct 2019
- YAD deadline is on 12 Oct 2019



Health

Key & Important Updates:

- Syrian American Medical Society (SAMS) project supporting with patient share at hospital level for children <18
- Palestinian Child Relief Fund (PCRF) coverage for children <18 in need for surgeries costing between 3,000USD – 5,000USD. Surgeries above 5,000USD can be co-shared.

The project is for the month of Oct only.

Social Stability

- Conflict sensitivity application workshop conducted to 4 partners nationally including Concern WW & UNDP from the north (3-4-5-6 Sep)
- Field consultation for SoSt sector strategy 2020 took place on Sep 19
- Next SWM TF on 23 October (ministry updates)
- Main tension highlights for September:

Eviction

- Dawse: 35 HHs at threat of eviction due to sanitation issue
- Rahbe: Threat of eviction by municipality (lack of residency)
- Bziza (threat)- paying municipal service fees.

Inter-community incidents/ arrests

- Assoun the body of a Syrian child has been taken out of its grave
- Number of disputes turned to violence (one woman killed)
- Some arrests on theft charges redcorded (Zgharta, Akkar & Tripoli)

Pressure on resources/LH

- SWM issue continues in the North – number of demonstrations continue
- the second installment of municipal dues was transferred to municipalities
- number of demonstrations liked to the economic situation

Relation with authorities

- Increased closure of shops
- Bziza: Demolition of IS (2 tents)
- Dar Baashtar: requesting annual service fees of 152,000LL



Inter-Agency Contingency Planning

Contingency Plan 2020: What is New?

The first Lebanon interagency contingency plan was produced in 2016, updated 2017 and 2018, with increasing focus on operational and areabased preparedness:

This year, review process involve:

- Light review of the contingency plan placing less focus on the actual scenarios and more emphasis on concrete operational preparedness at regional level.
- Area-based contingency plans, developed as part of multisectoral approach in 2018, are reviewed and enhanced.

Regional Planning Figures 2019

Scenario	Planning Figure
Renewed Armed Conflict with Israel	130,000 individuals overall figure: 125, 000 North and 5,000 Akkar (Lebanese-IDPs, current refugees) Based on UNICEF Contingency Planning Figures – 2019.
New Refugee Movements	No specific planning figure suggested in the north. Needs to be covered through regular response.
Armed Clashes in Palestinian Camps	70,000 refugees living in Badawi and Nahr El Bard camps. 2019 planning figures Crisis could manifest in the form of civil unrest, affecting PRL, PRS, Syrian Refugees and Lebanese.

- Early warning indicators and triggers
- Suggested coordination architecture
