




- We are a women's cooperative established by Syrian, Turkish and Afghan women beneficiaries of SADA Women Development and Solidarity Centre. Our cooperative was established on 25 March 2019 upon the application filed by 50 founding partners with Gaziantep Provincial Directorate of Trade.
- Keen to uphold the word "SADA" meaning voice in Arabic, our cooperative aspires to be the common voice, joint production premises and shared union of the women of different nationalities and cultures.

Our Vision

Empower women economically and socially through the solidarity of Turkish and refugee women.



Management and Organisation

At SADA Women's Cooperative, every partner has equal voice and participate actively in decision-making. We make decisions by exchanging views and voting in all processes ranging from naming the cooperative to selecting and designing its logo, from establishing management mechanisms to planning the work. All partners in our cooperative participate in production processes in the workshops of kitchen, textiles and shoe-upping based on their abilities. Our management board has 8 women. We also have the promotion and marketing commission and work organisation committee consisting of cooperative partners.




We participated in Gastro-Fest with our food products

IMPORTANT INFORMATION

FOR SYRIANS UNDER TEMPORARY PROTECTION IN ISTANBUL



Please note that in accordance with the Temporary Protection Regulation, Syrians under temporary protection are required to comply with the laws and administrative requirements put in place by the Directorate General of Migration Management (DGMM) and Governorates.

This includes the obligation to reside in a province, temporary accommodation centre or a specific place determined by DGMM, and to obtain a travel permission document to travel to a province other than your province of registration.

If you are a Syrian national registered as a temporary protection beneficiary in a province other than Istanbul, but you are residing in Istanbul without permission, you must approach the authorities as soon as possible. Please note that you must do this by 30 October at the latest.

If you are a Syrian who has not been registered in Turkey, but you are currently residing in Istanbul, you must approach the authorities as soon as possible. Please note that you must do this by 30 October at the latest. Upon approaching the authorities, you will be informed of the next steps for registration. Registration under temporary protection will allow you to benefit from rights and services, including healthcare, social assistance and education.

Procedures for Syrians registered outside of Istanbul

If you are registered in another province:

- You can obtain a travel permission document to enable your travel to your province of registration from the Provincial Directorate of Migration Management (PDMM) in Sultanbeyli and from mobile registration centres.
- Once the travel permission document has been issued, you will need to travel and present yourself to the PDMM in your province of registration within a week.

Procedures for Syrians who are not registered

If you are not yet registered:

- Please approach the Provincial Directorate of Migration Management (PDMM) in Sultanbeyli or the mobile registration centres. You will be fingerprinted and referred to a province for registration.
- You will be issued with a document to enable your travel to this province. Once it has been issued, you will need to travel and present yourself to the PDMM in that province within a week.
- Following the registration, you will be issued with a Registration Document; and if you approach PDMM 30 days after the registration, you will be given a Temporary Protection Identity Document.

Important

If you obtained a work permit in Istanbul or if you are currently pursuing your university education in Istanbul, please inform the Provincial Directorate of Migration Management (PDMM) in Sultanbeyli or mobile registration centres.

Please be aware that it is mandatory to comply with the relevant laws and administrative requirements. Sanctions will be applied to individuals who fail to comply with these obligations.

If you have a valid Temporary Protection ID (kimlik) or Registration

- On 20 August, a Migration Evaluation Meeting was held under the chairmanship of the Minister of Interior. While the details of the meeting was not made publicly available, the extension of the grace period from 20 August to 30 October was announced by the Minister.
- On 21 August, a press briefing was organized for foreign media representatives where the Minister made further statements related to Istanbul –
 - extension of the grace period; and
 - assurances against forcible returns to Syria noting Turkey's obligations under international law.



• On 27 August, Istanbul Governorate issued another press statement (*Irregular Migration, Unregistered Syrians, Informal Employment,*; 2019-48)

Between 12 July – 25 August 2019 under the coordination of our Governorate:

- Of Syrians who are registered in other provinces:
 - Students in primary and elementary schools in Istanbul in 2018-2019 academic year and their families,
 - With a view to the provision of the unity of family and humanitarian reasons, members of families registered elsewhere,
 - Children under the protection of their relatives who have lost their mothers or fathers (orphans),
 - Who have investments and provide with employment in Istanbul, owners of businesses and their family members who have been officially determined to be actively working three months prior to the application,
 - **o Students continuing their university education,**

Will be registered in Istanbul as long as they document their situations and as long as they meet the conditions as foreseen in the legislation.



- Units composed of the representatives of the Provincial Directorate of Social Security Institution and related institutions continue their counselling activities towards the prevention of informal employment.
 - 23,344 businesses have been visited and employers and workers were provided with counselling services.
 - Based on the requests of our artisans' chambers, counselling services initially indicated to be implemented until 25 August 2019 by our Governorate have been extended until 30 October 2019.
 - In the works towards rendering business signs in compliance with the legislation, 12,224 businesses were provided with counselling services.
- 437 business signs that were not compliant with the legislation were made compliant. Works towards rendering 1,681 business signs in compliance with the legislation continues.

- Procedures and implementation
 - Processing at two minivans belonging to DGMM at Esenyurt and Esenler bus terminal; and in Sultanbeyli PDMM
 - Issuance of travel permit for those registered.
 - Fingerprinting, recording of the basic bio data and issuance of a document to enable travel and referral to provinces of those unregistered.
 - Referral of unregistered Syrians to 52 provinces.
 - New registration in Istanbul exceptional categories.



Developments in Bursa

Similar measures like in Istanbul – announced by the Governorate of Bursa on 6 September.

- Signs in foreign languages of these businesses are made compliant with the legislation;
- Gaps in business registrations, tax liabilities and work permits are addressed.
- Foreigners who are registered under temporary protection in provinces other than Bursa will be directed to their provinces of residence or to one of the provinces they will be able to choose from.



Developments in Bursa

- Exceptional registration
 - Out of only those who have approached the Provincial Directorate of Migration Management for change of residential province, those who can document that their children are registered in schools in Bursa province for the 2018-2019 academic year,
 - Those who are considered under family reunification because of dependent children, those who are accessing higher education,
 - Those who have been issued work permits and their spouses and children,
 - Those children who are under the care of their relatives and separated from their families Those who due to their medical condition are hospitalized in Bursa or whose medical cares will be negatively impeded by transfer to another province as well their companions will be reassigned to Bursa as their province of residence.



Developments in Bursa

- In case unregistered Syrian foreigners PDMMs themselves, they will be referred to designated provinces for temporary protection registration procedure.
- Unregistered Syrian foreigners apprehended by the law enforcement will be referred to temporary accommodation centers for registration procedures.
- Unless in exceptional circumstances, Syrian foreigners will not be issued travel permits to Antalya, Aydin, Bursa, Canakkale, Duzce, Edirne, Hatay, Istanbul, Izmir, Kirklareli, Kocaeli, Mugla, Sakarya, Tekirdag, and Yalova provinces.



Developments in Istanbul

UNHCR support

UNHCR is supporting DGMM with approximatively 50 staff (receptionists, interviewers, security guards) to Istanbul and Oncupinar TAC (interviewers and protection desk staff).

Procedures for Syrians registered in Turkey

If already registered and in possession of a Temporary Protection ID card (kimlik), refugees will be issued with documents to enable return to the province where they are registered.

Individuals will be issued with a **notification document** (with the name of province of registration) to enable travel back to the province of registration.

If individuals do not have their Temporary Protection ID card, they will be given a copy of their Personal Information Form. **Refugees are expected to cover their own transportation-related costs.**

In the province of registration, individuals should approach PDMM within a week of the issuance date of the notification document.

At PDMM, individuals may be informed of a **reporting duty** that they will need to comply with, and present themselves to PDMM in that city at regular intervals.



If individuals **wish to return to Syria voluntarily**, they should express their intention to the PDMM officials for initiation of the procedures to return to Syria:

An **individual interview** will be conducted and individuals will be provided with counselling on the procedures and consequences of returning to Syria.

They will also be asked to sign the voluntary repatriation request form to record the voluntariness of their return to Syria.

If individuals sign a voluntary repatriation request form and agree to return to Syria, their temporary protection status in Turkey will end and they will not be able to return to Turkey.

Reinstatement of temporary protection status in this case may only be possible if a positive assessment is delivered by the national authorities following an individual interview.



If individuals are not registered in Turkey and wish to remain in Turkey:

The responsible personnel of PDMM at Oncupinar TAC will register them and **issue a Registration Document**.

Individuals will need to stay in Kilis province while their Temporary Protection ID card is being processed.

One month after registration, they can call the YIMER 157 call centre to make an appointment and approach PDMM Kilis Verification Centre to receive the new TP ID card.

While waiting for the TP ID card to be issued, individuals will have access emergency health services. Six months after registration, individuals can apply for a work permit through an employer.

Upon collection of the new TP ID card, **individuals can remain in Kilis or be referred to another province, that is open for referral**, by PDMM Kilis. They will also have access to Education. TP ID card for Kilis will not be issued, but a travel permission document so that individuals can travel to the other province where individuals can obtain their TP ID card.



UNHCR Support

- UNHCR Field staff are present daily (and at weekends) in Oncupinar and offering counselling to refugees and participating in voluntary return observations.
- Support to PDMM with deployment of additional staff.
- Information leaflet "Important Information for Syrian Nationals transferred to Oncupinar" currently with DGMM for final approval
- UNHCR Field staff have been identifying needs with regards to reception conditions, arrival times, transportation and accommodation and looking at how to address these with PDMM and DGMM
