Updates from Mahfazti	<ul style="list-style-type: none"> • The Central Bank of Jordan (CBJ), Jordan Mobile Payment Payments & Clearing Company (JoPACC) and PSPs are working on a country wide payment digitization. • CBJ, JoPACC and PSPs are considering delivering the assistance of National Aid Fund (NAF) to over 200 thousand families, especially for the day laborer who are severely are impacted with the lock-down. • CBJ will enable the on-line mobile self-registration for both individuals and merchants. • Small merchants (Mom-and-pop shops) can temporarily signup as individual wallets to receive payments. • Big merchants will have door-to-door delivery, and they will also receive ePayments. CBJ will work with PSPs to enable the payments for mouneh.jo online shopping up which will be announced by the government. • Mass communication (media/SMS) is planned by the government to inform the population about the availability of the on-line mobile self-registration with official links/apps/portal for registration. • Any cash transfer through mahfazti requires crediting in Mahfazti Escrow account directly depending on real-time gross settlement (RTGS) operation (bank to bank money transfers)

	<ul style="list-style-type: none"> • Any organization planning to contract with mahfazti need to contact the marketing manager, Mohammad Yassin @ myaseen@al-hulool.com. He will advise on the needed documentations and the bilateral contracting process under the CCF contact umbrella. • Authorized delivery companies will start to operate by Thu, stakeholders are working on enabling cash in/out to at the doorstep using P2P.
<p>Banking operations</p>	<ul style="list-style-type: none"> • As of 24 March, 70% of CAB ATMs are filled. CBJ gave permissions for banks to refill their ATMS starting from 26 March 2020. • Banking transfers are available daily from 10:00-14:00. • CAB can provide Cash on Wheels (mobile ATMs) for CCF members upon bilateral coordination and obtaining the government approvals. there are currently two mobile ATMs. • CAB requests CCF members to share with Rawan their upload plans prior to charging accounts on CAB portal and messaging their beneficiaries. Rawan will coordinate the CCF distribution as well as the national salaries to avoid crowdedness at ATMs. Main information to share: number of accounts to be recharged, total reload amount, beneficiaries' locations. • For any inquiries and requests for the CAB portal, contact Mouhsen Femas, at: MFERMAS@s2m.ma
<p>Cash Transfer coordination</p>	<p>In addition to the above coordination with CAB on cash distribution, CCF members needing to distribute existing ATM cards must follow the government policies on restricted movement and consider that refugees will not be able to travel to a distribution site.
