Introduction of new participants and agencies/organizat ional updates on ongoing activities	 New FSA sector coordinator Mr Ertan Aktan was introduced, and he will be leading the FSA sector and related 3RP inter-agency Turkey activities from now onwards. Update from IOM: IOM has livelihoods activities in Gaziantep, Sanliurfa, Hatay offices. As a cash grant intervention; 50 beneficiaries have been supported by IOM in Urfa, Gaziantep, Kilis, Sanliurfa, Hatay. IOM distributed cash and in kind grants to the beneficiaries. Preperation of success stories process is ongoing for Public Information (PI) publishment. Community farming activities are ongoing, training has been started to produce dried fruit and vegetable products for sale and distribution to the market. Under the Entreprize Development Fund (EDF), negotiations will start with the private companies. Two new entrepreneurship activities have initiated, with a collaboration with Mustafa Kemal University in Hatay and the other one is Cukurova University in Adana. The call for applications will last til the end of March. IOM is providing livestock to support 40 beneficiaries, which includes 50% SuTPs and 50% host communities, to the households in rural area located in Gaziantep and Sahinbey. Beneficiary selection criterias are, vulnebality, not having any income, living in rural areas, having livestock experiences, has been trained or willing to be trained by Sahinbey Municipality. The aim of the project is to increase economic and social status and quality of life of rural poor. Update from Concern Worldwide: Small grant and entreprenership training support activities are planned for 150 beneficiaries in Hatay, Kilis, Sanliurfa and Gaziantep. Applicaion link for grants will be shared with the FSA WG. 	

	 Update from ESSN Programme: ESSN programme has been extended for 1 more year until March 2022. So far, 9899 individuals are reached. Camp Food Programme has been extended until the 31 December 2021. Beneficiary cross-checking mechanism is changed to Kizilay Kart Platfrom Exchange Mechanism, thus widening the scope of its use by other organizations. Update from MoAF: Potential partnerships have been discussed between GIZ, FAO and MoAF. EU funded MADAD project is ongoing in a collaboration with FAO and MoAF. Training of Trainers (ToTs) will be organized nex week. For the visibility of the project, interviews will be held with Director General and counterparts. Farmer Field Schools will start next week. Under 2021 activities, refugees from any nationalities will benefit from the project. Strategic Development Department of MoAF is working on the Internal Strategy Document for Agriculture Sector. Updates will be shared with the FSA WG. 	
Presentation by UNHCR on FSA sector new indicators 2021- 2022 and reporting under Activity info	 At the start of the year, sectors set objectives, outputs and activity indicators were updated by the sector partners in order to measure progress towards the sector goals and to monitor activities of FSA Sector. Reports and correct data are coming from FSA sector partners through ActivityInfo, the extracted data then goes to the sector IM/sector coordinator for clearance before publishing on the sector dashboard for that month. The objective 1 is to improve the food security of Syrians under Temporary Protection and vulnerable communities and prevent them from resorting to food-related negative coping strategies. The objective 2 is to strengthen the resilience of Syrians under Temporary Protection and host communities by increasing self-reliance through employment, increased income and financial assets in the food and agriculture sectors. The objective 3 is to improve local and community-level public and private sector and civil society capacities to respond to the food and agriculture needs of impacted communities. Total Sectoral Appeal of FSA is 23,196,134 USD for 2021. Appealing agencies are ATAA, FAO, IOM, SHAFAK, UNDP, UNIDO, WATAN, WHH. The responsibilities of partners are to report on monthly achievements against the set indicators for each geographical location by the 10th of every month. It is important that all reporting partners submit the data in timely manner otherwise it would not be refelected in the sector dashboard and there might be a need to have a discussion around sector indicators to see what needs to be changed to report properly.
