


# **EUROPE RESETTLEMENT**

Regional Bureau for Europe | January - December 2020



# **OVERVIEW**

In 2020, due to the COVID-19 pandemic, UNHCR submitted just over 21,700 refugees for resettlement to eighteen countries in Europe, 36 per cent fewer than in 2019 (33,838), and 28 per cent fewer than the yearly average of 30,200 over the previous five years (2015-2019).1 COVID-19-related measures and the closure of EU external borders led to the disruption or temporary suspension of resettlement programmes in many European countries. Moreover, the temporary hold on resettlement travel announced by UNHCR and IOM in March 2020 as a result of pandemic-related government measures and disruptions to international air travel delayed the departures of some 10,000 accepted refugees to resettlement countries globally. This hold was eventually lifted in June, after which UNHCR encouraged States to resume travel arrangements.

Amid the COVID-19 pandemic, the European Commission's commitment remained significant as evidenced by the proposal in September 2020 of a new Pact on Migration and Asylum and a dedicated Recommendation on Legal Pathways to Protection in the EU. In this recommendation, the Commission called for States' efforts to build and expand resettlement programmes, develop community sponsorship programmes, and expand legal pathways to protection for refugees through humanitarian admissions, education and labour mobility pathways.

In 2020, Europe received 55 per cent of all UNHCR-facilitated resettlement submissions worldwide, the region's highest share since 2017. This was primarily due to a significant reduction in the scale of some other States' resettlement programmes in 2020.<sup>2</sup>


# Europe resettlement

# Resettlement submissions to Europe compared to global trends



#### **COUNTRIES OF ORIGIN**

As in 2019, the vast majority of refugees submitted for resettlement to Europe in 2020 were originally from the Syrian Arab Republic (Syria), their number having increased significantly between 2013 and 2016 in accordance with the increase in displacement from Syria during those years. Some 92 per cent of refugees submitted for resettlement to Europe in 2020 originate from six countries: Syria, the Democratic Republic of Congo, Eritrea, Sudan, South Sudan and Somalia.<sup>3</sup> Overall, 20 per cent of refugees submitted for resettlement in Europe were from East Africa and the Horn of Africa, 15 per cent from Central Africa and the Great Lakes, and 1 per cent each from South-West Asia and West Africa.

### **COUNTRIES OF ASYLUM**

Refugees submitted for resettlement to Europe were typically registered in the following countries: Syrian refugees in Lebanon, Turkey or Jordan; Congolese refugees (Democratic Republic of Congo) in Uganda, Rwanda or Kenya; Eritrean refugees in Ethiopia, Niger or Libya; Sudanese refugees in Egypt, Chad or Libya; South Sudanese refugees in Ethiopia, Egypt or Kenya; and Somali refugees in Kenya, Ethiopia or Niger.<sup>3</sup>

In November 2017, UNHCR and the Government of Niger established an Emergency Transit Mechanism (ETM), a lifesaving mechanism for the evacuation of the most vulnerable persons of concern from detention in Libya to Niger, to ensure their access to protection and durable solutions. In 2019, UNHCR, the Government of Rwanda and the African Union set up a second ETM in Rwanda for the same purpose.


In 2020, UNHCR made 315 resettlement submissions globally through the ETM in Rwanda and 677 submissions through the ETM in Niger.<sup>4</sup> In the same year, 599 refugees were resettled through the ETMs in Niger (403) and Rwanda (196), in addition to 151 other refugees resettled from Niger and 867 from Rwanda.

# **COUNTRIES OF RESETTLEMENT**


In 2020, five countries (Sweden, France, Norway, Germany and the United Kingdom) received 77 per cent of all submissions for resettlement in Europe.<sup>3</sup>

Of the eighteen European countries that received resettlement submissions in 2020, Belgium, Ireland, Italy, Spain, Romania and Portugal resettled predominantly Syrians, who comprised at least 90 per cent of the refugees resettled in these six countries. Sweden, Norway, France, the United Kingdom, Germany, Finland, Switzerland, the Netherlands and Denmark<sup>3</sup> also resettled substantial numbers of other nationalities, including refugees from the Democratic Republic of Congo, Eritrea, Sudan, South Sudan and Somalia.<sup>3</sup>


# Resettlement submissions to Europe (by country of origin)




# Resettlement submissions to Europe (by country of asylum)




# **CATEGORIES OF RESETTLEMENT SUBMISSIONS**


Resettlement remains an important tool to address protection needs of refugees who cannot access appropriate protection and support in their country of asylum, and to show solidarity with countries hosting large numbers of refugees. In 2020, resettlement submissions to European countries most commonly involved survivors of violence and/or torture (34 per cent), persons with individual legal and physical protection needs (29 per cent), and children and adolescents at risk (18 per cent).

### **Categories of resettlement submissions**










### **DEMOGRAPHICS**

Each resettlement case submitted to European countries in 2020 included four people on average. Overall, resettlement submissions to Europe comprised 52 per cent children, 46 per cent adults between the ages of 18 and 59 years, and 2 per cent persons age 60 and over. The number of submissions of women and girls (49 per cent) almost equalled that of men and boys (51 per cent). This demographic profile is mostly consistent with submissions in 2019.



#### Endnotes

- 1 The Europe region comprises 49 countries, including the EU Member States, Iceland, Liechtenstein, Norway, Switzerland, Turkey, the United Kingdom, Eastern Europe and South Eastern Europe (Kosovo (S/RES/1244 [1999]). Countries receiving resettlement submissions in 2020 are shown on the map on p.3.

The figures presented in this fact sheet reflect UNHCR submissions of resettlement cases to resettlement countries. Following submission, the timescale can vary in each resettlement country before a case is accepted, the refugees depart from their previous country of asylum and arrive finally in the country of resettlement.
- 3 Countries are listed in descending order by number of resettlement submissions.
- 4 During the 2020 calendar year, thirteen States allocated quotas for new resettlement submissions from Libya, Niger and Rwanda. These thirteen States include: Australia, Belgium, Canada, Denmark, Finland, France, Germany, Italy, the Netherlands, New Zealand, Norway, Sweden and the United States of America.
