Meeting Minutes







WHO, Trauma Center, UNHCR, MoI, UNICEF, IOM, IFRC, Hungarian Interchurch Aid, IRC

- St John Hospital: Prog Kurimay and Agnes are finalizing the introductive letter of MHPSS TF for ministries to strengthen the coordination on MHPSS. MHPSS TF members provided feedback on challenges and gaps in MHPSS coordination to be mentioned in the letter.
- IA Coordination: MHPSS data was shared between March to October (included) by the UNHCR IA team. A total of 12 MHPSS actors provided data on six different MHPSS activities (counseling, awareness raising, psychosocial support activities, training, and assessments). 25 981 people have received MHPSS services since March 2022.
- **UNHCR:** UNHCR Regional MHPSS Officer conducted a mission visit to Budapest to meet with the IA team and UNHCR's MHPSS partners. Also, supporting refugeeled organizations focusing on schooling activities for Ukrainian children.
- WHO: IASC/ WHO essential MHPSS guidelines in the Hungarian language will be finalized, including Minimum Service Mapping and Psychological First Aid.
- Trauma Center: A new project manager just started working on the new MHPSS project. Focusing on referral pathway and national MHPSS coordination, For further details, please see the presentation here. In addition, MHPSS service provision in continuing in 4 different temporary accommodation centers. Services included for also GBV survivors.
- **IOM:** MHPSS service provision is continuing in eight different shelter areas and closely following up on the needs and gaps in MHPSS with families, service providers, and international organizations.
- **Hungarian Interchurch Aid:** Sport center in the city center of Budapest. A new MHPSS project will be implemented starting in December. Support groups and specialized MHPSS counseling will be provided under the project.
- UNICEF: UNICEF established an entire team in Budapest, and MHPSS is a part of their intervention plans. Several accommodation centers are being supported through tdH and planning partnerships with national municipalities (Zahony, Debresen).
- IFRC: IFRC regional office supporting 13 counties from the Budapest office. Recently conducted PFA ToT, Hungarian RC also participated in that training. Also, caring for staff and volunteers is a big part of the IFRC's focus.
- Mol: Supporting MoH on MH Atlas regarding mental health data in Hungary. An
 advocacy document on MHPSS will be submitted to MoI; in this document, there
 may be a part for MHPSS service provision for refugees in Hungary. Mental health
 will be discussed in an interministerial meeting.
- IRC: A new MHPSS Advisor will start working and will be based in Athens.
