2. WHO Presentation on "Kosice Study"

WHO has conducted an assessment on Epidemiological study among refugees living in Košice. The total number of respondents were 290 and WHO shared preliminary results on medical chronic conditions, COVID vaccination, other vaccination status in adults, hypertension, asthma, diabetes, medication, disability, risk factors, anxiety, and access to health care. WHO is working on the final report.

IMWG co-chairs remind members the importance to update Assessment Registry for this new period 2023.

3. RRP 2023 – Next Steps

UNHCR focal point informed on the 2022 End of year response monitoring report that will be released with all 5W information consolidated from partners. This product will be shared publicly and will provide a general overview of the operational presence and response during 2022. This factsheet will complement the 5W dashboard updated on the Operational data portal with all 2022 information available.

UNHCR focal point informed about the upcoming launch of the Refugee Response Plan 2023 in Slovakia. On this regard, there will be a in-person Technical Workshop on the 2nd of February, that will include a presentation on the new reporting framework, new reporting system (Activity Info) and information on 2023 Plan (targets and budget). Invitation will be shared by the UNHCR Inter-Agency coordinator to all 2023 partners.
