Summary of discussions and agreements/ action points

Agenda	Discussion
<p>1. Temporary Protection Challenges Ion Bucur, Human Rights Monitor, <i>Centrul National Al Romilor</i></p> <p>Elena Sirbu, President, <i>Roma Women Platform Romni</i></p> <p>Sandu Sabina, protection officer, <i>UNHCR</i></p>	<p>Ion Bucur expressed the uncertainty of the documents needed to provide for the TP registration on the site.</p> <p>Elena Sirbu stated that many people are not informed about what TP means. The information presented on internet is mostly in English language- that is a problem for those who cannot read and write even in their language. Elena Sirbu also wondered who should issue the documents on accommodation.</p> <p>Sabina Sandu – protection officer – concluded that:</p> <ol style="list-style-type: none"> 1. <u>the rent contract of accommodation</u> is mandatory document while registering for TP, both for RACs and private. This document is establishing the relationship between the person who lends/ manager and the refugees/beneficiaries –people who live there. 2. declaration form filled by the legal entity (RAC) “декларация о предоставлении жилой площади” <p>It is not mandatory for the rent contract to be registered at fiscal office (FISC).</p> <p>Sabina Sandu, also informed that soon IGM (Insectoratul General pentru Migratie) will arrange trainings for the administrators of RACs. It will be done for a better collaboration of RACs’ managers and refugees, as well as for a better understanding of what specific documents should be issued by administrators of RACs.</p> <p>On IGM site there is a form that should be filled in by the private property lender.</p> <p>All the steps that should be undertaken are provided on official page of IGM, Temporary protection section.</p> <p>Sabina Sandu, informed on the agreement, that is in stage of discussion, between - CDA, INTERSOS National Congress of Ukrainean, Roma Mediators to be as implementing partners that will help in PRE-registration phase.</p>

<p>2. Main needs of Roma people, esp. women according to the assessment Alina Sava, field officer, <i>INTERSOS</i></p>	<p>Alina Sava, field officer, INTERSOS - has presented a PPT on main needs of Roma people. It will be sent in due time.</p>
<p>3. Presentation Winds of Peace – Glodeni activities REI DOI, <i>PEACE WINDS Japan</i></p> <p>Marin Alla, CEO, “Roma Voice” Coalition</p> <p>Irina Rusanovschi, President, <i>PHOENIX NGO</i></p>	<p>REI DOI, PEACE WINDS Japan presented a PPT on Glodeni educational activities. Please find it attached to the letter.</p> <p>Marin Alla informed about the CVR experience. CVR have made 3 visits to Glodeni in February- each time the smart class was closed, the computers were not working. CVR made its input by facilitating its opening, assuring the presence of the children on the lessons. CVR also talked to the parents raising awareness on the importance of education.</p> <p>It is very important to improve the easy access to the investments that are made. These assets should be not taken in the property of the RAC, of the Local Public Authorities. RTF is more than willing to help, so do not hesitate to ask for help, or any information relevant for RTF to be checked or redressed.</p> <p>Irina Rusanovschi talked about an issue regarding the presence of children in the smart classes: children are not willing to come at lunch time as they are on an online studying at Ukrainian School or they just want to play, so they always change the schedule to make it comfortable for both parts.</p>

Up-date on Roma Week agenda Cristina Sîrbu, Support Head of Mission, <i>INTERSOS</i></p>	<p>Cristina Sîrbu presented a draft of agenda for the Roma week.</p> <p>The partners are welcomed to offer any support or activities. AoB Elena Sirbu, President, <i>Roma Women</i> Platform Romni</p> <p>Marin Alla, CEO, <i>"Roma Voice"</i> Coalition</p>	<p>Elena Sirbu suggested to think about creating a more efficient complain feed-back mechanism. To improve that we already have.</p> <p>Marin Alla agreed, claiming that it would be a great idea to know what organization is doing what and asked to update the organizations and the services available.</p> <p>RTF is kindly requesting all the RTF partners to offer a short description of the ongoing activities targeted on Roma Group.</p>
