<p><b>Agenda point 1</b></p> <p><b>Updates from cash for rent group</b></p>	<p>The chairperson of the Task Force WG welcomed participants and thanked them for their presence.</p> <ul style="list-style-type: none"> <li>➤ Presentation of the agenda</li> </ul> <p><b>ACTED:</b> Purpose of the documents shared in the C4R group is the harmonization of all efforts. The SOP includes information that can be useful when new partners join. Main points are: transfer value, minimum rental standards, rental agreement support and coordination between partners. In the next meeting can present the final version of the SOP after considering the comments of the partners. The MOU on data sharing agreement is as simple as possible and focuses on the deduplication. It includes basic information like name, DoB, address, INDP. The signups for the program are closing today and will start registering the beneficiaries. The rental process will start at the beginning of June.</p> <p><b>UNHCR:</b> CRS and IOM inserted information with the locations of addresses to UNHCR housing mapping matrix. ACTED will do the same when they have the addresses of the beneficiaries.</p> <p><b>REACH:</b> asked whether excel sheets will be used for data deduplication <b>ACTED</b> commented that the only means of deduplication so far is the document to be signed <b>UNHCR</b> commented that any recommendation from <b>REACH</b> on that can be useful</p> <p><b>CRS:</b> shared documents of their outreach method of the visits to the communities. The material includes flyers, the minimum standards check list and rights and responsibilities for the refugees. <b>CRS</b> is mainly focusing on community-based outreach, not social media that much. The organization does not get involved in the lease agreement with the landlord, they just inform the refugees regarding the rental agreement.</p> <p><b>UNHCR</b> informed partners that there is a shared folder uploaded where they can upload their communication material. NRC has shared their lease agreement in different languages.</p> <p><b>ACTED</b> informed that the organization will not be part of any lease agreement, will only provide information to the refugees as advice on the procedure and their rights.</p> <p><b>UNHCR</b> mentioned that the RAC in Cahul will close in June and urged the partners to jointly visit the RAC and inform the people about their programs. Suggested the partners to be cautious with their outreach, they can share in the folder their communication, upload any related documents. ACTED SMS team visited all the RACs</p>	<p><b>ACTED</b> to insert in the housing matrix the locations of apartments when rental process starts.</p> <p><b>UNHCR</b> to share again the link to the shared folder of the C4R group</p>

Creating better conditions for households and institutions like schools, healthcare facilities connected to mobile supply.</p> <p><b>UNHCR:</b> Part of the Task Force is working on the community interventions in community centers can start gathering material from partners of what has been done and it can be inserted in the matrix. Need to continue working on the community intervention, need to discuss about the works in the community. Will share the guidance note on the community interventions.</p> <p><b>UNHCR</b> asked partners if they prefer to keep the task force or just the technical groups. The activities will switch more towards integration. Partners can work in the groups and share the results in the Basic needs working group. Partners agreed that the technical groups are more effective. The discussion in the basic needs group except for RACs will include more issues on mid-long term interventions. Next basic needs WG meeting on the 22<sup>nd</sup> of May, so inputs for housing, community interventions can be included in that meeting</p>
