For more information Contact Ramayana mahafza@unhcr.org or Soud ALSaker alsakr@unhcr.org for any questions. <p>Updates from field location:</p> <ul style="list-style-type: none"> • Irbid: <ul style="list-style-type: none"> - Irbid CP GBV SWG meeting took place on 8 Feb 2023, the ToR has been reviewed, and the work plan has been discussed and agreed upon by the group members. - International Women Day task force was created to conduct joint activities in Irbid on 9 Mar 2023, several organizations participated in the Taskforce meeting and shared their interest to join the joint activities. - Two FGDs were conducted by NHF and IRC responding to the national International Women Day task force to support drafting the key messages of the International Women Day campaign. • Azraq camp: <ul style="list-style-type: none"> - The Protection Unit conducted the Joint PWG & CP-SGBV SWG – Azraq meeting on 15 February 2023, which is chaired by UNHCR and co-chaired by DRC & IRC with the following agenda: International Women's 	

Day (08 March 2023), Update GBV Workplan, Protection 4W's (CBP), Sexual Harassment on the way to the school, Inclusion for PWD in the protection activities, EJC & Azraq Agency updates.

- The Task Force for the celebration of International Women Day (08 March) had two meetings on 21 & 28 February 2023 and discussed the national theme: making all spaces safe, International Theme: Innovation and technology for gender quality, key messages and activities. Will implement a walk-in activity (partners & refugees) and hoodies will be distributed to participants.

- UNHCR, IFH and IRC had a coordination meeting on 02 February 2023 and discussed the referral pathways of SGBV cases in Azraq camp to avoid any duplication in GBV case management between IRC and IFH, GBV case management for cases that need to be referred to UNHCR, complicated cases between UNHCR and IRC that need urgent follow up at both NRC female site and inside the camp & GBV Cash assistance SOPs.

- The Protection unit participated in a meeting with the protection partners (UNICEF, IMC, World Vision, Plan International & CARE) on 06 & 28 February 2023, and discussed the Sexual Harassment Action Plan and the Walk to School Initiative under Community Committees in Azraq camp.

- The Protection unit facilitated three PSEA & UNHCR Protection & Registration training for the National Security (69 participants) in the Azraq camp for the period 13-15 February 2023.

- The EJC Monthly Camp Coordination Meeting took place on 13 February 2023, at the SRAD site, issues were discussed: International Women's Day (08 March 2023) , Info-Sessions, Challenges and Agency updates.

- **Mafraq:**

- A meeting was conducted with partners - Mafraq level to discuss Prevention Activities that can conduct jointly and out of our centres.
- Regarding International Women Day they will have joint event with FPJD on 8-March-2023 and the agenda was submitted, and the invitation was sent through CPGBV WG-Mafraq.

- **Zaatari camp:**

- finalized updating coordination tools workplan and TOR's in addition to the mailing list,

<p>GBV SWG Workplan 2023 Finalization</p>	<ul style="list-style-type: none"> - The work plan activities that were discussed during the previous meeting were finalized and circulated to all SWG members to add their feedback and comments. - Notes are not received yet from all participants to be reviewed, compiled together and upload the final version on the portal. - Regarding the Protection Sector workshop that conducted on the 7th of Feb, the protection /CP and GBV TOR's including the vision have been reviewed and finalized according to the feedback and comments were collected by SWG members. - The shared comments that were shared by members were about involving the government in all our GBV activities and looking to other options rather than only NCFA and involving the MOSD and FPD in more activities to unify all the activities in one sector and one way. - The SOP and TOR of the GBV SWG should be updated to be more clear and more consistent in a way that connects all the points together. - Simplify and clarify the language to become a unified language between the CP and GBV. - The final version of new GBV Documents (TOR and SOP's) will be uploaded to the portal upon finalization - GBV strategy will be updated in the second half of the year. 	
<p>Campaigns</p>	<ul style="list-style-type: none"> - International Women's Day, - More than one meeting was held in the past month with members interested in participating in the task force for International Women's Day, five FGDs were held in five different locations (Azraq, ZRC, Mafrq, Irbid, and Amman) and more than 131 women and girls were reached and helped us in writing the key messages that will be shared during International Women's Day. - The Key messages have been finalized and will be shared with SWG members soon. - Social media package will be sent out next week for use during the International Women's Day campaign to ensure that all key messages used during the campaign are standardized across all organizations. - virtual events: safe space session will be conducted on 08.03.2023 through Twitter and the invitation will be sent to all SWG members to join the session to be part of it along with three
