


## Key figures at Regional level

New arrivals<sup>1</sup>: January-August 2023 vs. January-August 2022




Estimation of Persons of concern in Mixed Movment in the region as of 31 August:


19,863

Between January and August 2023, some 19,900 refugees and migrants were estimated to have transited through the Western Balkans as part of mixed movements, seven per cent less than in the same period last year. Given the nature of movement of these persons, including as a result of pushbacks and/or reverse flow, UNHCR uses data on arrivals to estimate how many persons are a part of mixed movements (MMs) in a given time period.

This data should not be considered final and may change as per the latest updates made available by the authorities. Persons in Mixed Movements (MMs) are considered 'new arrivals' as a part of irregular flow. Data on irregular arrivals and transit of persons through the countries in the Western Balkans may contain double counting of the same persons. It is, therefore, advised not to use the sum of these figures.




Forcibly Dislpaced and Stateless People presents at the end of August in each country:



Some **7,500** persons were present in the Western Balkans as of end August 2023, including **283** unaccompanied and separated children (UASC). Of these, 57% were present in Serbia, followed by Bosnia and Herzegovina (35%), Albania, Kosovo & Montenegro (two per cent each) and North Macedonia (one per cent ). This also includes estimated number of persons present outside government-run centres.

Forcibly Displaced and Stateless People presents in the Western Balkans countries are accommodated in government-run centres; IOM-run centres, asylum-seekers and persons granted international protection in asylum centres and persons on the move in transit centres.



Forcibly Dislpaced and Stateless People presents at the end of reporting period by month:




