2	Ionela shared an update about the recent WHO ToT for Health Managers on GBV.

	<p>The meeting was held in Tunis for EURO and EMRO regions. 5 participants; Carmen Niculescu (ANES); Ionela (EEIRH); Andreea Georgiana (WHO); Annet Nangonzi (WHO); Nicky Morgan (WHO). 3.5 days comprehensive training</p> <p>Topics covered and resources shared;</p> <ul style="list-style-type: none"> <li>• VAW as a PH problem</li> <li>• Guiding principles and minimum standards in an emergency setting-LIVES/MHPSS</li> <li>• Components of core protocols of SV and IPV for health providers</li> <li>• Facility readiness- including minimum requirements/SOPs/Protocols</li> <li>• Health workforce- Training</li> <li>• Infrastructure and supplies needed</li> <li>• Budget and financing- 2 useful online tools demonstrated</li> <li>• Referral patterns and pathways</li> <li>• Information for survivors and job aids for clinicians</li> <li>• Monitoring and Evaluation</li> </ul> <p>Best practice and exchanges of ideas took place among participants of different countries and an online environment will be set up by WHO to facilitate all participants to exchange ideas and share of resources.</p> <p>Carmen added that ANES are looking forward to the partnership between them and WHO and EEIRH and are looking to roll out the trainings to Health Managers in Romania.</p> <p>Annet shared plans for Cascading these trainings to health managers in December and for further trainings for Family Doctors in November.</p> <p>Irina shares that AMI are also running trainings for family doctors, nurses and midwives.</p> <p>There will be a partners coordination meeting planned for 14<sup>th</sup> November to share best practices for GBV support. This will be with MoH, ANES, and NGOs or CSOs working on GBV.</p>
3	<p>Carmen Radu from AMI shared an update about the presentation of the Care in Crisis report <a href="#">Care in Crisis: Failures to guarantee the sexual and reproductive health and rights of refugees from Ukraine in Hungary, Poland, Romania and Slovakia   Center for Reproductive Rights</a> to the European Parliament in Brussels and Strasbourg to mark International Abortion Day on 28<sup>th</sup> September.</p> <p>There was a press conference and there will be follow up with several documents and requests and an open letter to the MoH including a call for free contraception for vulnerable groups from Ukraine and in Romania.</p>
4	<p>The suggested RRP narrative was reviewed UNFPA suggested adding to PSEA/GBV support specific interventions such as CMR/IPV training and Ionela suggested adding Health Managers training. Other partners requested more time and were asked to send final submissions by midday Thursday 26<sup>th</sup> October.</p>
