Preparations for Round 8 of Inter-Agency Protection Needs Assessment *Objectives*



- Develop a better understanding of the protection and humanitarian situation in Türkiye.
- Establish a mechanism to systematically identify refugee needs in relation to thematic areas on protection, basic needs, livelihoods and education.
- Systematize and standardize data collection and analysis processes to better inform evidence-based programming and the larger refugee response (including via the 3RP).
- Inform and develop protection programming initiatives to address identified protection needs and gaps.
- Inform advocacy efforts on the local and central level with various stakeholders, including UN agencies, I/NGOs and public institutions.

Preparations for Round 8 of Inter-Agency Protection Needs Assessment Methodology



- For the assessment, a sample household-level survey will be conducted
- As in previous rounds, face-to-face and telephone interviews will be used for data collection methods.
- The questionnaire will be revised based on feedback received from our partners and coordinators, the outputs of the short survey sent out in the previous weeks, and the suggestions we will discuss in this meeting.
- The assessment will be conducted based on the informed consent (obtained in line with the national Law on Protection of Personal Data No.6698) of the interviewee.
- Considering there are ongoing data collection and analysis exercises with regards to the earthquake situation,
 Round 8 will not include any specific areas/questions related to the impact of the earthquake.

Preparations for Round 8 of Inter-Agency Protection Needs Assessment Sampling



- A stratified sampling methodology will be adopted to ensure adequate representation across refugee groups and that nuances across different geographical areas are captured, both which will allow for comparative analysis.
- The sample size for this round is expected to be around 2,400 households.
- In addition to publicly available statistics produced by the Presidency of Migration Management (for Syrians under Temporary Protection), partner databases will be used to identify the sample pool and a proportional sample will be created for each partner.
- Unlike the previous round, inclusion of Turkish citizens to the sample is not planned in Round 8.

Preparations for Round 8 of Inter-Agency Protection Needs Assessment *Timeline*



- Official call to partners: 14th of May
- Questionnaire feedback: 28th of May for partners
- Partner input for sample identification: 3 10th of June
- Training for enumerators and interpreters: Week of 10th of June TBC
- Communication with partners on sample size: 14th of June
- Data collection: 24 June 12 July
- Data cleaning and analysis: Mid July End of July -TBC
- Preliminary analysis: End of July TBC
- Comprehensive report: August TBC
- Clearance & Translation: September TBC

Preparations for Round 8 of Inter-Agency Protection Needs Assessment Outputs




- The findings will be widely shared with decision makers within the humanitarian community and within public institutions, as well as to donors.
- Widespread sharing of and reference to these findings is intended to strengthen evidence-based programming and implementation, as well as inform advocacy efforts with a variety of stakeholders.
- These findings shape the strategy and program implementation of the 3RP Protection Sector, as well as inform discussions on various coordination platforms.
- Sector partners will be provided with guidance on recommendations for scope and content of appeals based on the analysis provided throughout the report on communities' unmet needs, preferences and capacities.
- Findings will also inform the sector's inputs in the annual 3RP Türkiye Monitoring & Evaluation report.

Survey Outputs for Identifying Data and Information Gaps in the Protection Sector - 1



Overview of thematic areas still considered relevant to the Round 8

- The top three thematic areas considered most relevant are as follows:
 - Protection and community concerns
 - Work, income and basic needs
 - Access to services
- As can be seen from the graph, belowmentioned areas are followed by access to civil documentation, participant information and demographics, access to social assistance, access to information and access to education.



Survey Outputs for Identifying Data and Information Gaps in the Protection Sector - 2



Output of new thematic areas that should be included in the Round 8 questionnaire - 1

- Collecting data on access to and quality of Mental Health and Psychosocial Support services.
- Gathering information on digital literacy and access to technology for accessing information.
- Adding more detailed questions on social cohesion and integration.
- Collecting more detailed information on access to education, including motivations to participate in vocational and language courses, extracurricular activities, and recreational programs for children.
- Collecting information on access to childcare and support for working parents in the context of the work, income, and basic needs.
- Adding new questions for LGBTQI+ inclusion and support.

Survey Outputs for Identifying Data and Information Gaps in the Protection Sector - 3



Output of new thematic areas that should be included in the Round 8 questionnaire - 2

- Adding new questions within the scope of disability inclusion.
- Collecting more detailed information on persons on the move.
- Gathering more detailed information within the scope of legal clinics.
- Elaborating questions within the scope of the use of feedback and complaints mechanisms (e.g., YİMER, CİMER).
- Adding questions concerning PSEA allegations and where to report these allegations.
- Asking broader questions related to resilience, social coping strategies, environmental conditions, and living conditions.

Survey Outputs for Identifying Data and Information Gaps in the Protection Sector - 4



Recommendations for the IA/IM team leading the exercise or for contributing partners to improve the overall effectiveness of the exercise

- Establishing various communication and sharing platforms to enhance the effectiveness of the analysis.
- Increasing the use of tools such as press releases, webinars, or reports to reach a wider audience with the results of the analysis.
- Ensuring that survey questions are concise and comprehensible, and prioritizing face-to-face interviews over telephone surveys.
- Identifying strengths and weaknesses after each round of analysis and disseminating lessons learned and best practices from past analyses.



Information about Participants


- A total of 103

- 94% of the participating organization representatives stated that they were actively involved in earthquake response efforts.













Performing of Coordination Tasks





Effectiveness of Response







- 38% of the respondents indicated that different stakeholders should be included in the meetings with the majority underlining the need for increased participation from public institutions.
- 53% of respondents stated that there should be more intersectoral discussions.
 - Every 2-3 months
 - Health and psycho-social support
- 25% of respondents indicated the need for Arabic translation.
- 97% of the respondents would like the meetings to continue in a hybrid format.







Were you able to utilize resources under 3RP for the EQ response?

he EQ Were you able to make use of existing coordination mechanisms towards implementing a more effective response?


Did you have a clear understanding of the evolution/transition of coordination mechanisms?








How effective were existing coordination mechanisms in supporting the emergency response?




How flexible were the existing coordination mechanisms in accommodating an emergency situation?






Information Management Processes During EQ Response


Were you able to make use of existing information management tools and platforms towards implementing a more effective response?






Overview of Progress Against 3RP Accountability Indicators Reporting 3RP National Protection Sector Coordinator


Overview of Progress Against 3RP Accountability Indicators Reporting
