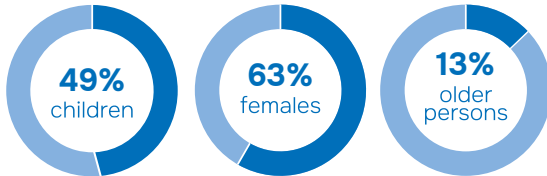

Moldovan municipalities deepen efforts for inclusive local development

In April, UNHCR marked key milestones under the Cities of Solidarity initiative, aimed at promoting social inclusion for displaced persons and vulnerable Moldovans. On 8th April, a Memorandum of Cooperation (MoC) was signed with the Comrat Mayor's Office to formalise joint efforts in inclusive community development. Later that month, on 24th April, a similar MoC was signed in Balti, where UNHCR and local authorities also launched a Peaceful Coexistence Project, including the opening of a multifunctional sports field to foster youth engagement and social cohesion. The same day, a new Balti Community Service Centre was inaugurated, with partners such as IOM, UNFPA, ACTED, and the Norwegian Embassy. These developments highlight UNHCR's ongoing collaboration with municipalities to build inclusive and resilient communities across Moldova. This is achieved through initiatives that facilitate access to essential services—such as employment counselling, social assistance, language courses, cultural activities, and community-based support—while also improving local infrastructure and fostering inclusive participation in community life. Together, these efforts strengthen social cohesion and benefit both refugees and host communities.

Child-led protection for safer schools

To support the creation of child-friendly school environments, UNHCR and its partner, the National Centre for Child Abuse Prevention (CNPAC), organised a training session on Children's Participation in Decision-Making and the Development of School Protection Policies. Attended by educators and child protection staff from across Moldova, the session focused on involving children in shaping school safety policies and preventing violence. To address bullying and create safer spaces for all children—especially refugee children—the training equipped school personnel with tools to foster inclusive, protective learning environments. It strengthened participants' capacity to develop child-centred policies and implement practical measures for violence prevention, promoting a culture of accountability, respect, and active student engagement.

Collaborative response to mitigate funding gaps and sustain support for refugees

To ensure continuity of services amid resource constraints, UNHCR held consultations with 24 national and local Refugee Response Plan (RRP) partners, as well as with refugees and host communities, to assess the impact of funding shortfalls and jointly identify mitigation strategies. These discussions provided a space for partners to share operational challenges, reassess priorities, and adapt implementation plans. In this context, priorities were tailored to the most pressing needs of refugees—ensuring the continuation of critical services such as legal assistance, basic needs support, and targeted assistance for the most vulnerable, including children, older persons, and persons with disabilities among others. As a result, activities and budgets were jointly revised to minimise disruptions in refugee assistance and uphold protection for those most at risk, amid widespread funding shortfalls affecting the most vulnerable.

Strengthening border and protection systems

The Office of the People's Advocate, in collaboration with Moldova State University, UNHCR, and the Council of Europe Office in Chişinău, organized the first National Scientific Conference "Current Challenges in Border Security and International Protection." The event brought together 42 contributors and over 130 participants from Moldova and abroad to discuss migration, human rights, and border security, within the framework of Moldova's international obligations and European aspirations. The conference produced recommendations for legislative reform and stronger alignment with international protection standards. These outcomes informed national policy discussions and supported efforts to enhance Moldova's asylum and border management systems.



A delegation from Moldova—comprising representatives from the Ministry of Internal Affairs, General Inspectorate for Migration, Law Centre of Advocates, and UNHCR—visited Switzerland to explore good practices in refugee reception and integration. Hosted by the Swiss Secretariat for Migration (SEM) and UNHCR Switzerland, the team toured reception centres and met with key actors to learn how fair asylum procedures and strong integration policies support those forced to flee. The insights gained will help strengthen Moldova's asylum system and improve support services for refugees, contributing to more effective and humane protection practices.
