#### Overview of the sector and narrative

#### The Sector Overview:

The livelihoods and resilience sector aims to ensure refugees and host communities live peacefully while progressively pursuing self-reliance in an enabling environment that supports sustainable responses and inclusive livelihood opportunities. To contribute to this, partners facilitate economic inclusion of refugees by improving access to arable land for agriculture; supporting mechanized farm operations i.e. use of tractors to expand access to land for agriculture production; providing agro-inputs and training in agricultural practices as well as entrepreneurship, business development services and financial inclusion aimed at access to formal financial services. During quarter one, the Government and UNHCR joint advocacy efforts focused on supporting the formalization of land use or access arrangements between refugees and landlords. This ensures that even where customary ownership of land is prevalent, access to land for livelihoods and agriculture is transparent and risks of exploitation linked to informal arrangements, which is common in the refugee settlements are minimized.

#### The Result Analysis:

During the first quarter of 2025, refugees were supported to access about 4,757 acres of land, a 228% increase compared to the 1,449 acres accessed during quarter one in 2024. The marked increase is attributed to enhanced and concerted advocacy by UNHCR, government, and partners to support refugees access to agriculture land for cultivation. With the ongoing progressive food ration cuts in Uganda by the World Food Programme, coupled with year-on -year decline in funding for humanitarian and development efforts; refugees own food production is critical in supporting food availability and food access at the household level. By the end of Quarter one, despite receiving 99,923 new arrivals (64% from the DR Congo), only 6% equivalent to 6,461 households received emergency livelihood support. The support comprised assorted agricultural inputs (seeds, farm tools, and animal health kits). Partners trained 8,590 beneficiaries in good agronomic practices compared to 27,246 reported trained in same period in 2024. This represents a 68% decline in agricultural training. Overall, agriculture production support in Quarter 1 of 2025, declined compared to support provided during the same period in 2024. This can be attributed to several contextual developments including the closure of several multi-year projects due to a significant reduction in funding to sector partners; downsizing of operations by response actors leaving limited resources for food security and livelihoods; De-prioritization of overall food security and livelihood support in overall humanitarian programming to focus on essential services and emergency lifesaving support.

#### The Key Challenges/Opportunities:

Progressive and sudden food ration cuts are negatively impacting refugee communities, resulting in increased pressure on household income sources, scarce land available for agriculture production and potentially reduced impact and undoing of years of gains accrued collectively by actors in livelihoods and economic inclusion programming. Increasingly, the operation is experiencing low appetite among development and private sector actors to invest in refugee hosting areas. This has left first responders mainly local actors and community level structures with limited to no resources to continue supporting critical selfreliance interventions. The unabated and continued inflow of refugees to Uganda; owing to conflict in South Sudan, Sudan and DR Congo, has increased pressure on available land further shrinking available land for agriculture production and limiting access to land for households' own food production. This will undoubtedly impact dietary diversity leaving families at huge risk of malnutrition. Food insecurity among refugee households remains high at 61%; including huge gaps in non-food essential needs provision which directly impacts economic food access. At a macro-level, inflation rose to 3.9% in April from 3.6% in March, mainly driven by higher food prices. Worse still, refugees continue to encounter bottlenecks in attempts to secure credit, especially from formal sources, due to weak socio-economic status, lack of conventional accepted collateral and slow 'Know-Your-Customer '(KYC) data verification. These call for enhanced advocacy with financial institutions and regulators as well as with the National Identification and Registration Authority with the aim of establishing interoperability between NIRA database and the refugee data, to enable on-time KYC verification for refugees. Administrative barriers in facilitating access to work in the formal economy remain with challenges in accessing work permits. This further creates an additional hurdle for refugees in the face of high unemployment rates in the host economy. Despite hosting over 1 million refugees, Uganda's Refugee Response is facing severe impacts from the global decline in humanitarian funding. Donor cuts, including to multi-year funding, have forced partners to shut down projects, close offices, and lay off 641 staff, including key technical experts. A UNHCR assessment in early 2025 revealed that 511,942 people (416,811 refugees and 95,131 host community members) are missing vital livelihood support, a number expected to rise. Coupled with WFP food aid cuts, these funding gaps threaten food security and refugee livelihoods.


#### The Sector Priorities:


Advocacy with Government and host communities for increased refugee access to agriculture land remains an urgent and a top priority for the sector. The sector will continue to undertake dedicated conversations to explore possible options to support refugees access to land and advance strategic collaborations with partners to ensure livelihood interventions leverage and optimize available resources; to ensure that even in the face of declining funding, the limited available resources are used effectively to support refugees and hosting community. Through data and information management coordination, the sector is focusing on improving the recording of livelihood beneficiaries' data, to minimize duplication; strengthen synergies for improved program design and effective targeting. By quarter 3 of 2025, and in close collaboration with Ministry of Gender and Labour Social Development (MGSLD); the sector plans to roll out Self-Reliance Index across 13 refugee-hosting settlements. Amidst a challenging and rapidly evolving funding landscape; the sector continues to advocate for multiyear funding and strengthening of thematic coordination. This includes sharing best practices and lessons learned, including in key emerging programming areas such as graduation that is through graduation community of practice in Uganda; the Self Reliance Index reference group focusing on self-reliance model; access to marketable value chains for forcibly displaced persons, market systems development, skills development for gainful employment and labor mobility pathways under solutions; entrepreneurship, and inclusive employment linkages targeting host community and refugees at both national and settlement level.





Acres of land accessed by refugees and host community





#### Partner reporting by district | South West & Kampala















#### Partner reporting by district | West Nile & North

A total of 41 partners reported during Q1, same number of partners compared to Q1 2024. Overall, the West Nile/North districts had the highest number of partners reporting, with Yumbe, home to the Bidibidi settlement, with the highest number of reporting partners.

In contrast, the South West region saw fewer partners reporting; Isingiro district, where Nakivale and Oruchinga settlements are located, had the highest number of partners reporting in that area.




