## Context

Panama's asylum system remains complex. While the country is party to the 1951 Convention and the 1967 Protocol, its national legislation has yet to adopt the broader refugee definition outlined in the Cartagena Declaration. Limited access to documentation and restrictive labour regulations continue to impact the protection and integration of refugees and asylum-seekers.

This quarter, Panama's National Commission for Refugee Protection (CONARE) granted refugee status to 21 individuals, including eight Afghans, seven Colombians, five Nicaraguans, and one Ghanian. UNHCR provided technical support throughout the process, contributing to the analysis and strengthening of refugee status determination procedures.


In June, authorities extended the validity of the humanitarian permits for 49 of the 299 US deportees who arrived in February, allowing them to remain legally in the country for an additional six months. The group includes Somalis, Iranians, Afghans, Russians, and Ethiopians and relies on support from private, faith-based, and international partners.

UNHCR donated two fully equipped mobile units to the Ombudsperson's Office to strengthen its capacity to address protection needs, particularly in remote and underserved areas hosting refugees and asylum-seekers. These mobile units will expand the Ombudsperson's Office outreach and legal guidance capacity to respond more effectively to vulnerable populations.



#### **UNHCR RESPONSE**





**Coordination with Local Authorities** | UNHCR supported the relaunch of the National Office for the Attention of Refugees (ONPAR)'s ID issuance system inactive since 2021, through targeted donations. The system now restores asylum-seekers' access to official documentation confirming their application is in process. UNHCR participated in the International Congress on Human Mobility and Human Rights, moderating a panel on preventing discrimination against displaced populations.




**Protection** UNHCR trained 15 mentors from the 'Impulsa tu Negocio' project led by FCDS on international protection to enhance their support for refugee entrepreneurs. UNHCR also trained 19 students from El Colegio de Panamá to lead community activities inspired by the book 'La otra orilla', building skills in public speaking and engagement with refugee communities.



**Humanitarian Assistance** | Through CRP, UNHCR provided primary healthcare services to 30 people, including refugees and asylum-seekers, at the Government's Temporary Reception Centres (ETRM). Through HIAS, the Agency assisted 1,152 people in border areas with Mental Health and Psychosocial Support (MHPSS) services related to traumatic experiences fleeing their home country.



**Local Integration** | UNHCR participated in the CRP's community fair, which welcomed some 400 people, including refugees and asylum-seekers. Students from El Colegio de Panamá led recreational activities, while UNHCR hosted a banner initiative where refugees shared messages about acts of solidarity from their host communities. UNHCR monitored the new inclusive facility of FDCS's 'Creciendo Juntos' programme, which provides refugees and asylum-seekers with spaces for training, livelihood support, and community-building activities.
