

Lebanon Response Plan - 2025

The Lebanon Response Plan 2024-2025 (LRP) is an integrated humanitarian and stabilization response plan co-led by the Government of Lebanon and the United Nations, supported by international and national partners. The plan sets out to respond to challenges in a holistic manner through providing immediate assistance to and ensuring protection of vulnerable populations; supporting service provision through national systems; and supporting Lebanon's economic, social and environmental stability. Based on the needs identified by affected communities, the Government and its partners, the LRP presents a prioritized and evidence-based appeal of \$2.99 billion in 2025 to fund partners' coordinated interventions across eleven sectors. LRP Sector Dashboards - Mid-Year 2025

The mid-year 2025 sector dashboards summarize progress made by sector partners under the Lebanon Response Plan (LRP) for the first half of 2025. Dashboards include reporting on populations reached versus targets set, funding, achievements, challenges, and continuing priorities for the remainder of 2025. LRP Funding Update - Mid-Year 2025

769 million USD was made available by Q2 2025 to partners for interventions under the LRP including funding directly received and carry-over/multi-year funding contributions made previously for 2024. This equates to 26 per cent of the LRP partner appeal that was set for the year (3.006 billion USD). The funding update is developed by analyzing and consolidating the figures shared by the LRP partners through the Lebanon Aid Tracking System at the end of each quarter. LRP Overview and Scope - Mid-Year 2025

LRP Support to Lebanese Dashboard - Mid-Year 2025

The LRP Support to Lebanese dashboard provides examples of assistance to vulnerable Lebanese provided across sectors under the LRP.

The LRP targets 1.7 million vulnerable Lebanese, 1.3 million displaced Syrians, 200,000 Palestine Refugees in Lebanon, 23,026 Palestinian Refugees from Syria, and 175,974 Migrants. In recent years, support to Lebanese has increased across sectors in response to growing needs. The Mid-Year Update on the LRP Support to Lebanese dashboard is available here in Arabic and English.

Water on the Edge: Lebanon's Drought Crisis Demands Immediate International Support - 2025

This WaSH Sector Alert serves as an early warning and advocacy tool in response to Lebanon's most severe drought on record, with rainfall over 50% below average and growing pressure on water infrastructure and services. The alert highlights emerging impacts on public health, agriculture, and access to water, while calling attention to urgent preparedness needs. A national Drought Vulnerability Map - based on a Composite Drought Vulnerability Index (DVI) - identifies 274 cadasters as highly or very highly vulnerable, using indicators such as groundwater quality, aquifer resilience, land use, population pressure, and climatic stress. The document outlines priority actions for emergency response and long-term resilience, and calls for \$42.2 million in funding to sustain water access and strengthen Lebanon's climate-resilient WaSH systems. Housing, Land, and Property Documentation in the South of Lebanon: A Rapid Needs Assessment

This rapid need assessment was conducted by IOM to strengthen the evidence base on the emerging issue of Housing, Land, and Property (HLP) documentation, and to develop an understanding of the needs and vulnerabilities of affected communities. The objective of this assessment is to better understand whether: HLP ownership documentation was lost or destroyed during the recent iteration of conflict; affected populations and stakeholders see the lack of HLP ownership documentation as a challenge to rebuild their lives after displacement; communities and government counterparts believe there is a role for the humanitarian community to address these challenges; affected communities identify any potential risks to social cohesion due to the damage and destruction of property and documentation.
