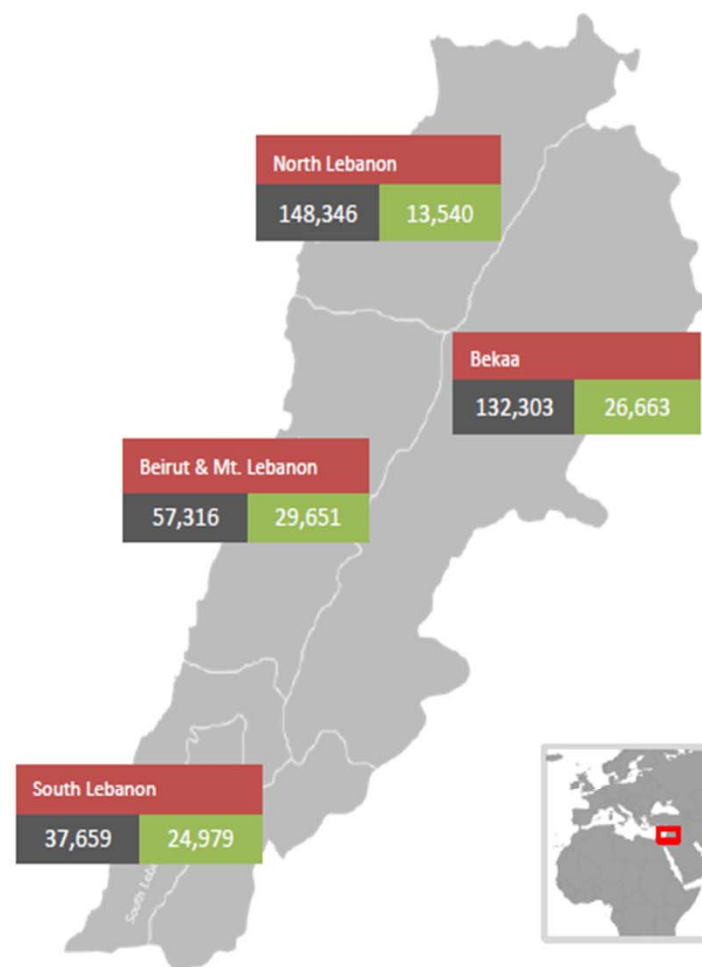

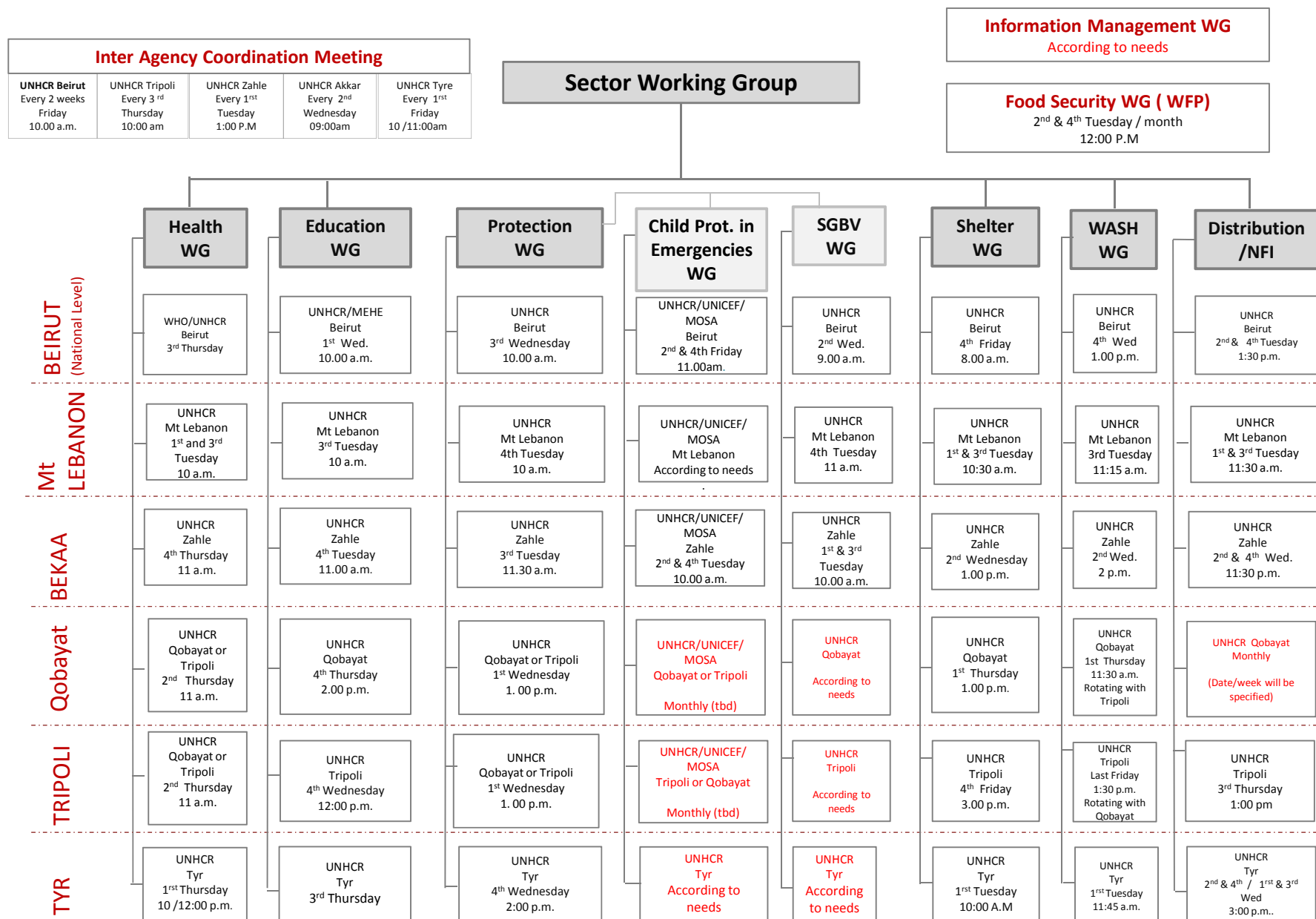

# Review IA Contingency Plan

Purpose of this CP is to define the preparedness & response actions to cope with the following scenarios:

1. A more massive influx of refugees into Lebanon (than RRP5):
  - a) Escalation of violence / complete disintegration in Syria leading to mass influx of approx. 50,000 refugees into Lebanon in a single day (through all crossing points)
  - b) An influx that significantly exceeds current trends → i.e. nearly a million more than RRP5 projection, arriving during the rest of 2013
2. Mass internal displacement of refugees + IDPs due to violence within Lebanese territory
3. A major epidemic outbreak (a section of the overall UNCT CP)

**‘Triggers’ for activation of the CP are being defined not only at national level, but more importantly at area level**

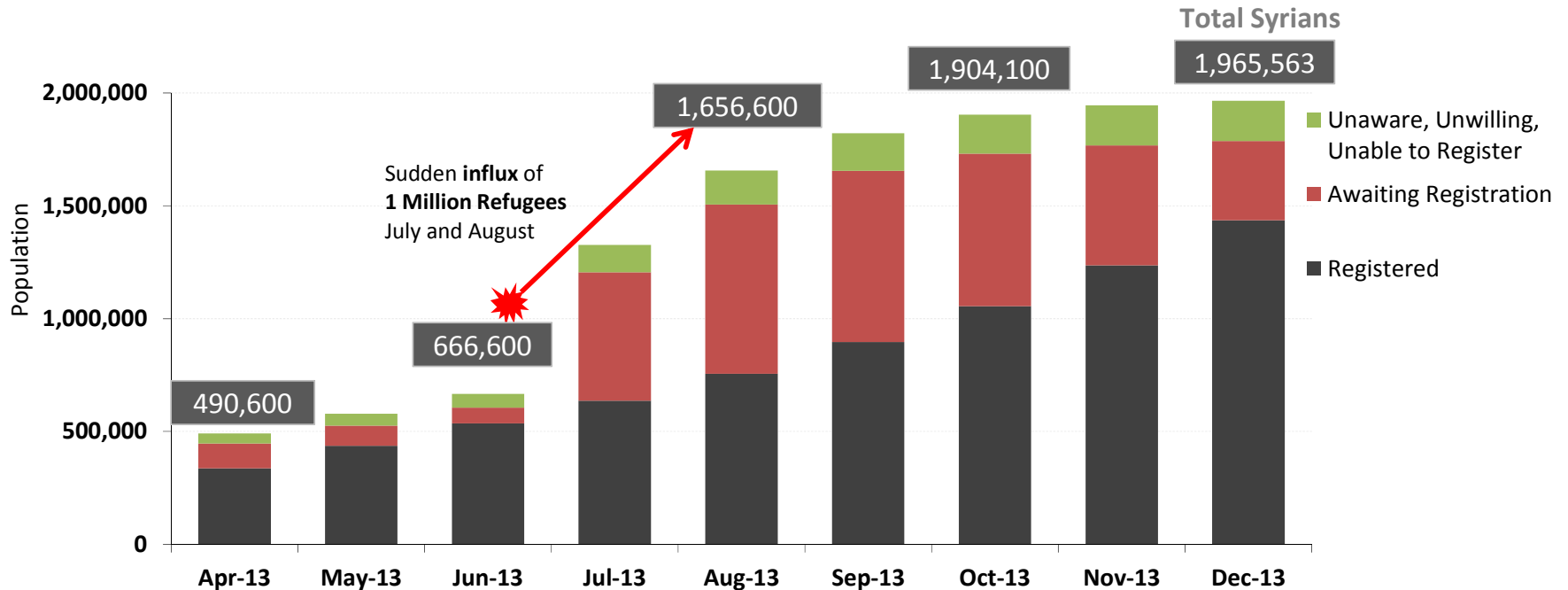

# SECTOR UPDATES



# PROTECTION-Update

## Highlights:

**Registration:** More than 90,000 refugees registered in April, an 80% increase from March and total number pending decreased 25% since last inter-agency meeting. Waiting periods decreased to 15-28 days in most locations, except the South, which decreased from 71 to 48 days. New registration sites in MTL and Bekaa currently being assessed to expand capacity.

**Akkar:** In last two weeks, large number of new arrivals (430+ families) from Qusayr in Wadi Khaled, 70% irregular crossing without documentation. Many arrived in Aarsal first then through Hermel to Wadi Khaled. Mortal shelling hit outskirts of al-Aboudiyah and Janine and Qashlaq border village, close to one collective shelter. Refugees were monitored but none relocated.

**Tripoli:** On 8 May, Tripoli registration centre relocated to new premises - ex-UNRWA compound. Refugee focal point training given on legal aspects of asylum, documentation and residency permits.



# PROTECTION-Update

## Highlights:

**Bekaa:** Monitoring in Aarsal indicates 90% of new arrivals are women and children, following reports males over 15 face cannot leave conflict areas in Syria and face possible mistreatment. Some movement from Hermel to Zahle due to security and ongoing security concerns in Masharih al-Qaa area, including reported eviction threats to residents. Mapping of SDCs & community centres and gaps analysis conducted.

**Tyre:** Agreement reached with LAF on access to refugees south of 'security belt', whereby LAF authorizes and UNHCR assists in transport. Tensions emerging in Bint Jbeil and Kana involving attacks on Syrians by host community. One family was relocated.

## Action Points:

- Next national PWG meeting on 22 May
- Mapping of restrictions on freedom of movement ongoing



# SGBV TASK FORCE-Update

## Highlights:

- In April the SGBV Task Force with support from ECHO and IRC organized 3 4- day emergency preparedness and response workshops and trained 80 staff from 20 organizations
- A working lunch with head of agencies and donors was organized on 30 April
- This week a team from the SGBV Task Force comprise of MOSA, Abaad, UNICEF, UNFPA and UNHCR participated in a regional interagency SGBV workshop on the Syria response.



# Child Protection in Emergencies (CPiE)-Update

## Highlights:

- Activity Mapping of CPiE members
- Completion of Regional Remote Syria Child Protection Needs Assessment
  - Participation of 7 agencies; 235 respondents; 45% female vs 55% male
  - Next Steps – Interpretation workshop in June in Amman; Report drafted by end-July
- Initiated process to harmonise and strengthen case management tools
- Compilation of Children at Risk data from SR registration points - higher proportion of separated children, child spouses, child labour, children with severe disabilities

## Action Points:

- Ongoing identification of referral pathways per field hub
- Capacity Building Workshop on Child Friendly Spaces and Psychosocial Support - May 27<sup>th</sup> to 31<sup>st</sup>
- Complete standardisation of recreation and early childhood development kits.





# SHELTER-Update

## Highlights:

- Joint UNHCR-MoSA assessments of a transit site ongoing. Chaat – North Bekaa for 7,500 individuals.
- 15,886 HH received shelter support as of May 2013.
- Shelter Poll Survey Conducted.

## Action Points:

- Identification and mapping informal tented settlements in North, Akkar, and Bekaa finalised.
- A joint inter-sectorial SOP to informal tented settlements is being finalized.
- 21 buildings are planned/ongoing rehabilitation for over 550 HH in collective centers.

# Methodology

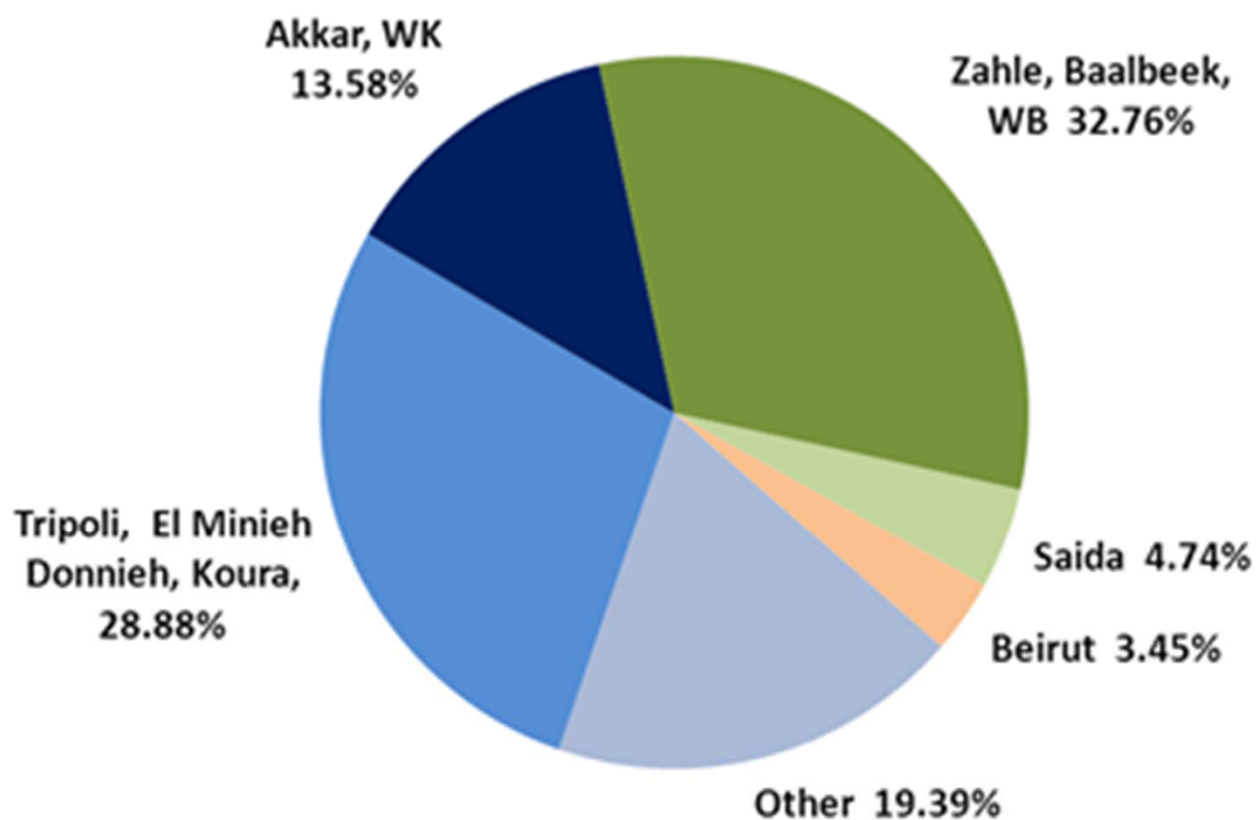


- Sampling of 464 respondents randomly selected from UNHCR database of 49,000 families
- Survey conducted between March to April
- Country level coverage on registered refugees
- Confidence level 94.43%

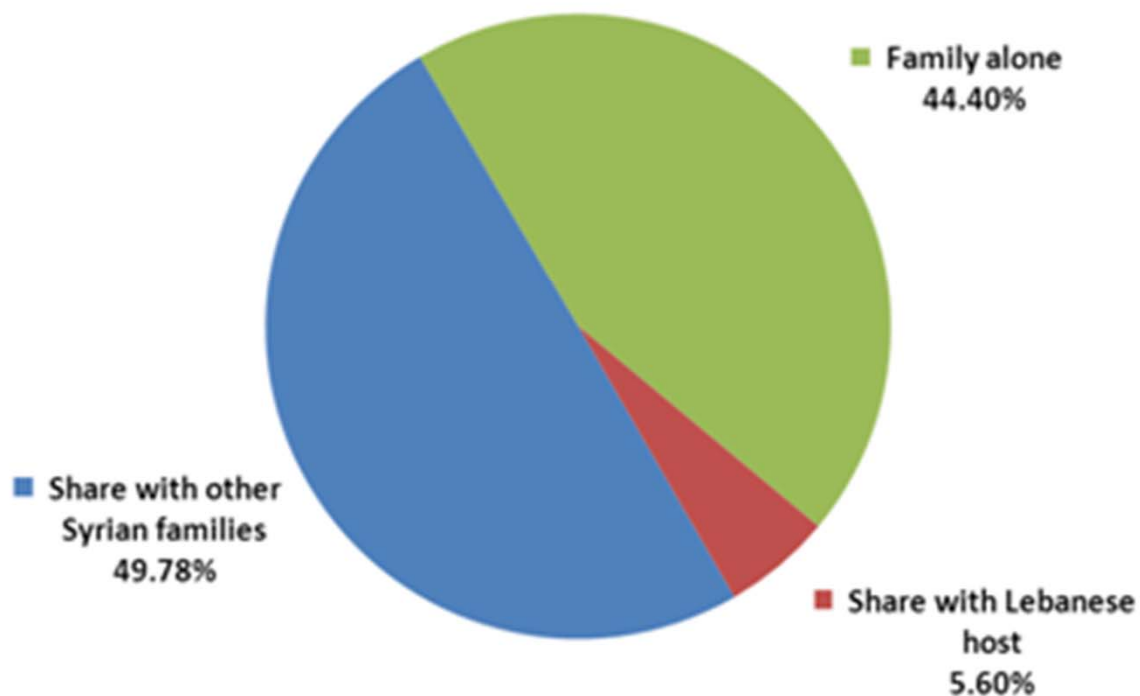


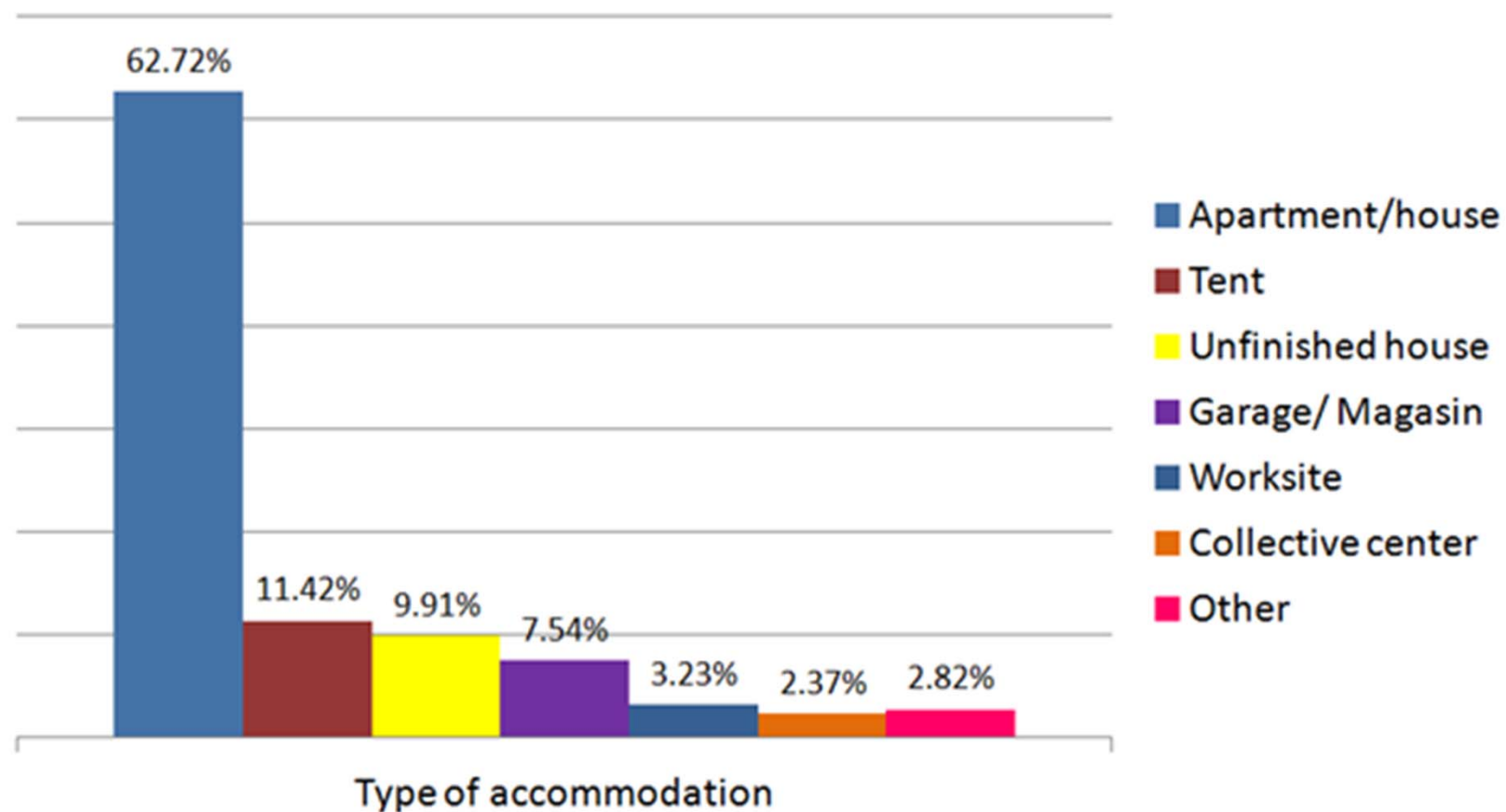

### Respondents per region

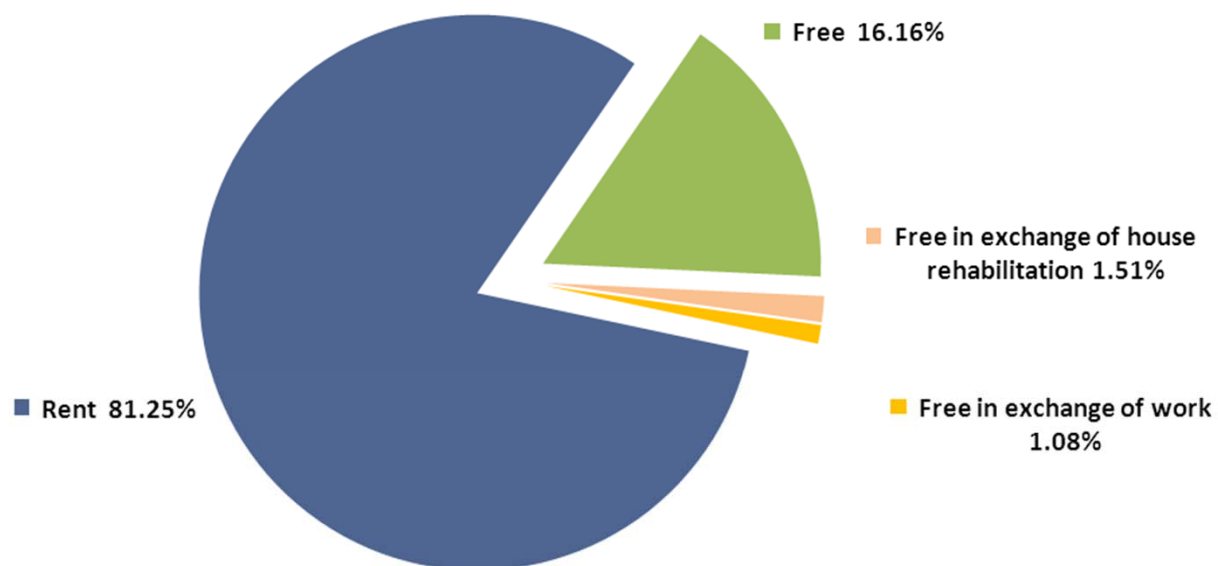


### Respondents' Housing

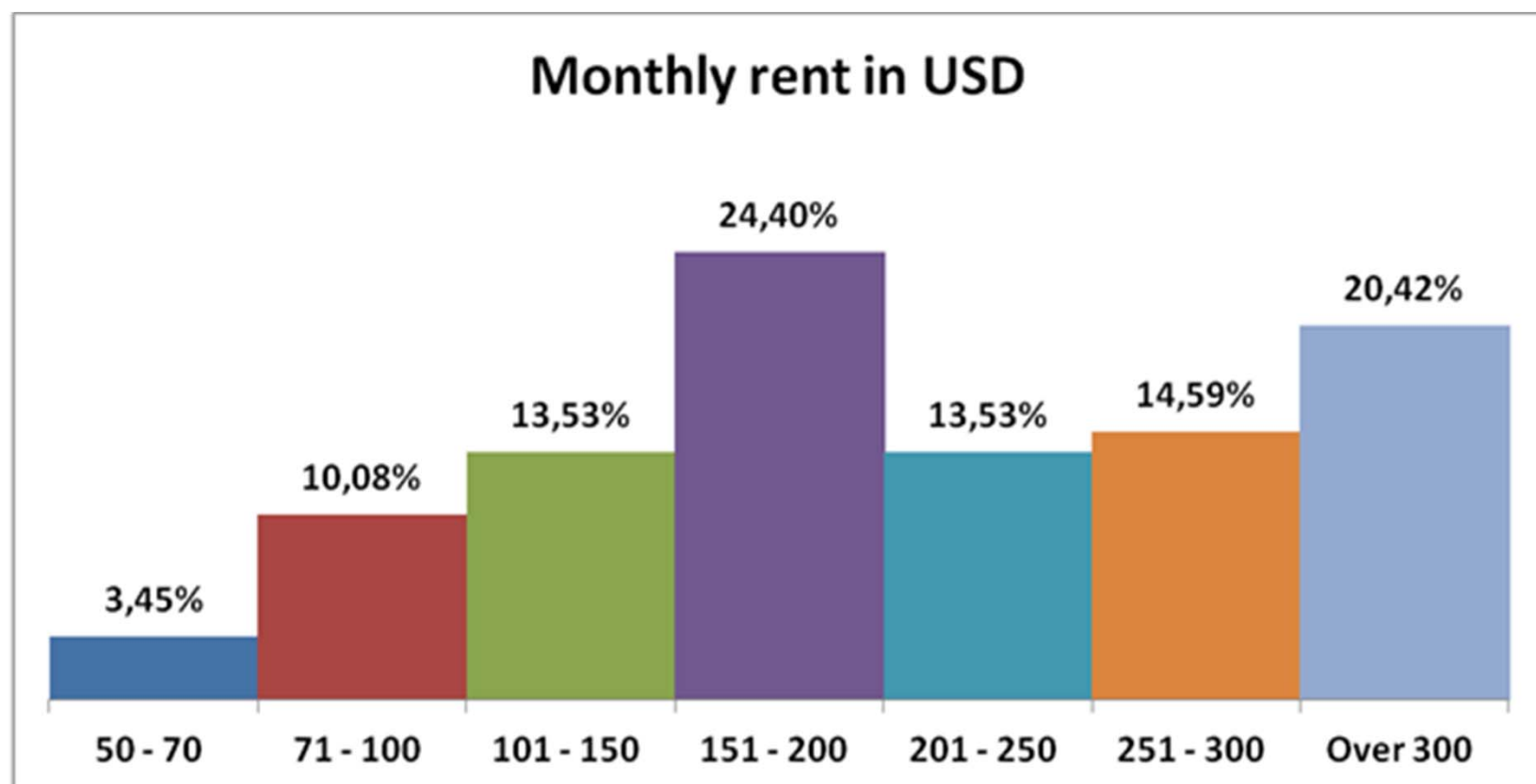


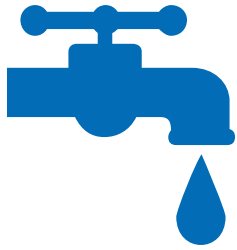

# WASH - UPDATES

## Highlights:

- Field level WASH coordination meetings have started from May in all Governorates.
- WASH Contingency stock reviewed.
- Health/WASH response to Scabies and Lice in tented settlements ongoing.

## Action Points:

- Finalize technical documents on water, sanitation and hygiene promotion.
- Finalize 5W (who, what, where, when and to whom) and WASH mapping tools.



# PUBLIC HEALTH-Update

## Highlights:

- Final map & 3W matrix of the Syria refugee response health care center distribution
- MMU mapping and service delivery plan
- Final SOPs on referral care,
- Follow up meeting with partners held cross sectoral coordination on diseases linked to WASH and shelter conditions

## Action Points:

- Poster and brochures for refugees
- Identification of Mt Lebanon hospitals to fill service gap for SHC after HCG
- Follow up meetings on contingency planning as well as outbreak preparedness & response scheduled



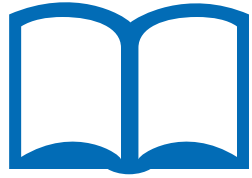
# Food Security - WFP

## Highlights:

- WFP voucher distributions in Wadi Khaled have resumed though the security situation remains a real concern. WFP and partners are still receiving anonymous threats.
- WFP partnership with local bank for the launch of the E-Vouchers is in the final stages of negotiation. The delays mean that a pilot project will be launched in June. Full roll out will be aligned with future targeting.
- WFP has finalized the comprehensive questionnaire for the profiling exercise. Training of enumerators will begin next week and data collection the following week.

## Action Points:

- Continue to monitor the situation in Wadi Khaled. If necessary, WFP may be forced to revert to distributions of food parcels.
- Finalize contract with tender-winning bank.
- Train enumerators and begin data collection.



# EDUCATION - Update

## Highlights:

- The Joint Education Needs Assessment started all across the country and preliminary results expected by end of May.
- Examination decree still a major concern
- Head lice and scabies treatments for 70,000 children in schools in progress.



# NFI-Update

## Highlights:

- Standardized Newcomer HH Assessment Form now completed
- RRP5 final submission for NFIs:
  - ✓ \$41m (RRP4) + \$148m (new) = \$189m total
  - ✓ UNHCR \$60m; DRC \$43m; Islamic Relief \$17m; Govt \$11m; WV \$10m
  - ✓ Winter needs (output 1): \$60m for 91,000 families / 445,000 indiv.
  - ✓ Emerging needs (output 2): \$40m for 125,000 families / 604,000 indiv.
  - ✓ Contingency Stock (output 5): for \$22m for 39,000 families / 195,000 indiv.



# NFI-Update

## Action Points:

- Standardized rapid assessment form for mass influx under preparation
- Rapid response teams to deal with local-level emergencies under creation
- NFI Assistance SOP still in draft form / 'flyer' for donors not started
- Contingency planning effort → need for simulation exercises & training
- Geo-Division of 1 agency per 'P-code' currently on-hold but already identified as urgent through current CP exercise
