

## Oxfam Jordan - Final vulnerability scoring system for Syrian Refugee Families

**10 Points** is the threshold for High Vulnerability (and inclusion in Oxfam's programme)

Conditions in Green highlight are automatic qualifications, which are confirmed through home visits.

Conditions in Purple highlight are used only through referral by specialised agencies.

## **Oxfam - Balqa Registration May-June 2013 (Safut, Ayn al Basha and Baqaa) = 674 families scored**

Highly Vulnerable	Score of 10 to 14	186 families (27,5 %)
Vulnerable	Score of 6 to 9	134 families (19,9 %)
Low Vulnerability	Score of 2 to 5	77 families (11,4 %)

**Home Visits** were carried out for 197 families (score of 10 including Severe Medical/Disability)

Positive Verification for more than 95% of families

**Cross-checking with UNHCR** Cash Assistance (2 days turnaround)

Out of 674 families interviewed, 60 were receiving regular UNHCR cash assistance. Only 25 had withheld this information during Registration; another 35 (5%) reported this at Registration.

### **Strong Points**

- Robust scoring system with clear exclusion/inclusion outcomes; including guidance for “extremely vulnerable”
- Scoring system with very low influence of economic factors (rent, income-expenditure gap, reported incomes)
- Working with Local Charities for Registration = geographically specific area (community mobilisation strategy)
- 20-minute questionnaire; able to register up to 100 families per day with maximum attention to dignity/privacy/limited waiting time (with team of 12)

### **Challenges**

- Transparency/Accountability on Criteria vs inviting honest reporting
- Lack of Medical/Disability capacity in Oxfam → identify partnerships with specialist NGOs
- Labor Intensive Home Visits with low added value
- Multiple families qualifying per household (maximum of 2 agreed)
