Presentation of the interagency emergency SOPs on CP and GBV

A presentation was made on the SOPs by Save the Children secondee to UNHCR, Ms Amanda Melville (Amanda.melville@savethechildren.org; Melville@unhcr.org). The presentation was a brief overview of the SOPs and the tools contained within the package including referral pathways/forms, case management tools.

Three ToTs will take place over coming months with the next taking place 16-18 December. Regular training on the SOPs will also be conducted at the governorate level (Irbid, Mafraq, Zarqa). Any interested parties should contact Amanda on the details above if interested.

Other sectors will also be invited to attend the trainings starting with Health and Education partners. The Ministry of Health (MoH) will also be invited to take part.

Inter-sectorial referral mapping (out-of-camp)

UNHCR in collaboration with other partners is initiating a cross-sectorial mapping of referral mechanisms. An initial meeting was held in Irbid and a subsequent one will take place over the next couple of weeks in the south (date and location TBD). A further expansion to other governorates will take place after that.

The idea, once the mapping has taken place, is to explore the best possible software and database to accommodate out-of-camp referrals in Jordan. UNHCR currently uses the Refugee Assistance Information System (RAIS) which, once freed from use as an emergency registration tool in Zaatari, could provide an effective platform. It is currently being used for cash and health referrals but could be expanded to other sectors as needs be.

Simultaneously, UNHCR is reviewing its own referral pathways and has created a list of focal points in UNHCR to be shared with partners. This will also be accompanied by a FAQ document which discusses processes within UNHCR but which goes above and beyond referral mechanisms.

Presentation of the 16 Days of Activism plans and calendar

The 16 days of activism run from 25th November – 10th December. In there is a busy calendar with 5-10 events happening per day and a total of 23 organisations involved. Many women's CBOs and development actors are also taking part.

Update/presentation on the RRP6

A short presentation was given on the RRP6 and the latest figures as of 26/11. Protection has the second largest budget after food in the RRP6 with a total of 169,076,190 USD being requested for protection. This is a 43% increase from RRP5. The total requested amount for RRP6 is 1,200,650,591 USD

Objective 2, Output 4 in the protection chapter of RRP6, relating to livelihoods and self-reliance has been renamed. The new phrasing is as follows: "# wgbm participating in self-reliance activities, post-basic education, and accessing life skills training".

A new reporting tool for the RRP process will be made available to partners by UNHCR in Activity Info.

The next dates to note in the RRP process are as follows:

5th December – monthly reports due on RRP5

10th December – last review of RRP6

15th December – launch of RRP6




- All agencies requested to submit RRP5 reporting by 5th December at the latest. Protection was the last to submit for October. Timely submission kindly requested.
