

# CP and GBV Joint Working Group – Za’atari

## Thursday, April 10<sup>th</sup> 2014 @ 11:30 – UNHCR Meeting Room Za’atari - Minutes

**Chairs:** SCI and IRC

**Participants:** IRC, UNHCR, NRC, SCI, REACH, UNICEF, IRD, IMC, UN-Women, OXFAM, WFP.

### ➤ **Introduction:**

The chairs and members agreed the meeting to define the CP – GBV working group in Za’atari and its way forward. This includes separation vs “togetherness” of the groups, operational structure, membership and coordination mechanisms.

### ➤ **Operational Structures, Membership and Coordination – Endorsed decisions (summary)\*:**

- **Group separated** – One CP Working Group and one GBV Working Group established in the Za’atari: Effective starting date 10<sup>th</sup> April 2014;
- **Reasoning** – improve time and quality of focused discussions and strengthen potential to identify and address group specific concerns;
- **Membership** – membership = commitment – member of a group can also be member of the other group. **Action Point** = GBV/CP chairs will share membership table – to be returned by Thursday 17<sup>th</sup> April COB.
- **Structure** – the groups will have two different TORs and work-plans, one vs two chairs to be discussed internally by the group, bi-weekly meeting and 5<sup>th</sup> joint meeting, establishment of three levels coordination mechanisms:
  - a) **Coordination between Za’atari CP and Za’atari GBV - WG** – Joint meetings, establishment of focal point system, common mailing list, updating docs on UNHCR portal;
  - b) **Coordination between the CP and the GBV Working Group and the Protection Working group in Za’atari:** Establishment of a focal point system, sharing of docs and minutes, protection FP in GBV/CP mailings.
  - c) **Between the CP and GBV Working Groups in Za’atari and the CP and GBV working groups at the National Level (Amman):** share updates; focal point in mailing lists, monthly presentation (two-ways – from Amman to Za’atari – from Za’atari to Amman).

### ➤ **AOB**

- **Interagency CP/GBV project:** posters on the prevention messages being finalized. They will be distributed once ready. Interagency PC and GBV messages are being translated into Arabic and will be shared once reviewed.
- **Opening of Sharia Court in Zaatri Camp:** next Monday 14-4-2014 will be on duty. Information to be provided during next meetings on further details on referrals, operation hours, coordination with other agencies, etc...
- **WFP: E-voucher system:** will start 15<sup>th</sup> April as a pilot for 200 families and on 24<sup>th</sup> April there will be a presentation on messages to be distributed to the community..
