1) Review previous minutes and action points -Transport guidance note being finalised; Teacher code of conduct still at MoE; INEE MS WG – received some expressions of interest; some Letters of Commitment have been received, but still many to respond; ESWG Chairs to meet next week with CP SWG to discuss sector training on CP/GBV SOPs; awaiting feedback from MoE on key documents; 4Ws for host community incomplete- partners to send inputs to Reem Nashashibi (rnashashibi@unicef.org).

2) Presentation on "Gender Equality in and through Education" - Inter-Agency GenCap Advisor, Merrin Waterhouse, presented on how to assess different needs of women, girls, boys and men and address these specific needs and the basics of gender-equality measures. Group exercise to familiarise with the INEE handbook on 'Gender Equality in and through Education', which was distributed. (see attached presentation). WG members drew up a short list of possible gender-equality measures that GenCAP and SAG will follow up.

3) Update on the coordinated needs assessment workshop and brainstorming exercise on coordinated needs assessments – Chair informed about the Inter-Sector Working Group held a 'Coordinated Needs Assessment workshop' on 29 January. Group exercise and discussion on current practices, challenges and possible solutions to ensure coordinated needs assessments within and amongst sector.
